# Capture the Election Discussion Date Set

#### By Michele McGowen

n Friday, December 14, 2012 from 12:00 noon - 1:30 p.m. League members are invited to gather, review, and discuss the campaign material (print, radio, TV and robocalls) from the Michigan Supreme Court election. Bring any campaign material you received and notes you took from radio and television ads. Questions we will be using as a discussion guide include:

- Who distributed more literature? e.g., candidates v. interest groups; candidates in hotly contested races v. shoe-ins; incumbents v. challengers
- How does advertising by the candidate's campaign compare to advertising by interest groups? (in terms of volume/ frequency; support or opposition for a specific candidate; positive or negative; general tone)
- Who sponsors political advertising? Are sponsors recognizable by name?
- Who do you think paid for the third-party ads (use specific examples of sponsors)? If you can't tell, could you find out?
- Did you notice differences among third-party ads that might explain why sponsors are required to report their contributors for some types of ads but not others? (Ads that don't explicitly call for a vote for or against a candidate are not subject to disclosure laws.)
- General discussion about observations, concerns, likes and dislikes.

## **Does Michigan Need a Genuine Progress Indicator?**

A GPI would measure the health of many of the systems that are so important to League members.

he LWVKA recently asked the LWVMI to begin advocating for a state Genuine Progress Indicator (GPI). A GPI would measure the health of many of the systems that are so important to League members: representative government structures, social policies, and natural resources.

The GPI is a tool promoted by individuals and groups that recognize the limitations of the methods currently used to measure a society's progress. The Gross Domestic Product, for example, does not measure the distribution of wealth or look at how money is being spent. It does not look at the depletion of natural capital or what is happening to our environment. It ignores many of the good things in a society, such as volunteer work, parenting in the home, and public investments in education and research.

Advocates of the GPI suggest measuring things like life expectancy, poverty rates, unemployment rates, disposable income, education levels, the state of natural resources, environmental pollution, waste, human health, satisfaction with life, and standards of living. Maryland and Vermont have already taken action to develop new tools.

Individuals interested in learning more about these initiatives may want to research "Beyond GDP" and/or "Genuine Progress Indicator."

## **LWVKA Fall Forums**

LWVKA hosts wellattended forums.

e had a busy election season this fall hosting three candidate forums. The Comstock Township Candidate Forum was a well-attended event held on September 19 in partnership with the Comstock Community Center. Details were described in the November *Bulletin*.

To meet the challenge of sponsoring a forum for the 20 Kalamazoo County Commission candidates, we decided to host a video event. Public Media Network recorded individual interviews of 13 candidates who participated at scheduled times over a two-day period. Videos were posted on our website, available to viewers at their convenience. League members **Fran Eckenrode, Karen Eddy, Denise Hartsough, Terry Hluchyj, Carol Urban,** and **Jack Urban** assisted in that project. On October 24, we co-sponsored a wellattended forum with the Kalamazoo Bar Association at the Kalamazoo Public Library. Featuring candidates for Kalamazoo Prosecuting Attorney and Kalamazoo County Sheriff, the event was recorded by Public Media Network for broadcast on cable channel 95. League members Denise Hartsough moderated the forum, while Ken Manley did the timekeeping. Connie Ferguson, Terry Hluchyj, and Paula Manley collected and prepared the many questions suggested by the audience of approximately 50 people. Because there wasn't sufficient time to ask all the questions, we added a new feature to our process by later sending the list of unasked audience questions to the candidates.

Thanks to all members who assisted with and attended these important voter service events.

# **High School Voter Education Project 2012**

Area high school students had a real voting experience.

he Mock Election was held October 23, 2012, at Kalamazoo Central, Loy Norrix, Phoenix High School and the Kresa Young Adult Program. The students used real voting machines, application to vote forms, official ballots printed for the mock election, voting carrels, and each received an "I Voted" sticker. Several students served as poll workers at the mock election and some were trained to be poll workers on November 6 in Kalamazoo City precincts.

All this was made possible by the City and County Clerks and especially the Deputy City Clerk, Shelby Moss. City poll workers and LWVKA volunteers **Cheryl Lyon-Jenness, Sabrina Pritchett-Evans, Louise Robeck, Janet Scarrow, Lyda Stillwell, Sara Wick, Diane Worden** and **Jackie Wylie** helped. Committee members Paula Aldridge, Kay Anderson, Jennie Hill, Michele McGowen and Georgiann McWilliams put in many hours to make this a successful project.

On November 26, **Dr. Michael Rice** announced the results at a press conference. The results were also reported on MLive and the *Kalamazoo Gazette*. **President Obama** won the student election, claiming 81.4% of the vote compared to 14.3% for challenger **Mitt Romney**. Other Democratic candidates did very well among student voters. A majority favored Proposals 1 through 5, while Proposal 6 was 50.3% no. Student voters also supported the Metro transit millage.

The League received a \$2,500.00 grant from the John E. Fetzer Institute Fund, Kalamazoo Community Foundation. The mock election ballots were printed by Michigan Election Resources.

## VOTE411 a Success this Elec-

tion VOTE411.org provided crucial election information for over 2 million voters in 2012, had almost 800,000 visitors on November 5 and 6 alone, and was a crucial resource for many of the volunteers staffing election hotlines across the country! We were proud to partner with LWVNJ, LWVNY and LWVNYC to provide up-to-date information for voters impacted by Hurricane Sandy. Of the over 2 million visitors, more than 570,000 viewed the online candidate information Leagues in 30 states worked incredibly hard to provide. Through VOTE411 the League provided at least basic candidate information for candidates down through the State House in all 50 states and DC, displaying over 11,000 candidates for the General Election! Along with the online candidate information, VOTE411 provided information on over 370 candidate debates and forums and linked to over 170 printed voter guides from Leagues around the country! LWVEF thanks all members for their hard work creating voters' guides, hosting events, protecting voters' rights and engaging your communities in Election 2012!

#### **LWVUS Board Adopts Tentative Scope for Agriculture Update**

The LWVUS Board has named the study passed by Convention 2012 as the Agriculture Update. Subject to review and recommendation by the Update Committee, the Board also adopted this scope for the update: "The Agriculture Update will focus narrowly on (1) current technology issues in agriculture including genetically modified organisms (GMOs), herbicides, pesticides, sustainable farming, agriculture water pollution, aquifer depletion, antibiotics in livestock, and accurate food labeling; and (2) current agriculture finance issues including consolidation in agriculture industries, crop subsidies and the federal agricultural regulatory process." Further information and an online committee application form will be announced in subsequent Leaders' Updates.

## Supreme Court Set to Hear Arguments on the Voting Rights

**Act** On November 9, the U.S. Supreme Court decided to hear a case that challenges the Voting Rights Act. LWVUS President **Elisabeth MacNamara** issued the following statement:

"Today, the Supreme Court decided to review the constitutionality of the Voting Rights Act. In a week when American democracy was on display for all the world, this action by the Court is a huge step in the wrong direction. The Voting Rights Act is an essential part of American democracy. The thought that the Supreme Court might overrule Congress and take away voting rights should send a chill down the spine of every American. The Voting Rights Act ensures that every American has an equal right to vote. With the problems in our election system exposed once again this week, the Supreme Court should be enforcing voting rights, not taking them away."

## League Sends Letter to Congress on "Fiscal Cliff," Taxes

**and Budget** The letter was sent to the U.S. House and Senate and delivered by members of the LWVUS Lobby Corps to select offices on the Hill. The League urges Congress to provide a long-term solution by substantially increasing revenue, protecting

the social safety net, reducing defense spending and carefully managing the deficit. Send your own letter.

We Need to Fix That On election night, President Obama stated "we need to fix that," referring to the long lines on Election Day. Over the next several months the League of Women Voters will be working with coalition members to develop a list of election reforms that will help address the various issues related to our elections, and we'll continue to work with you (key state Leagues) to address specific strategies in your states. Wendy Weiser from the Brennan Center has shared their views on some fixes which you can read.

**2013 LWVMI Convention** Planning is underway for the 2013 LWVMI State Convention that will be held May 17-19 at the Radisson Hotel at the Capitol in downtown Lansing. The theme will be "Advocacy - Powering Our Voices." Watch *League Links* and *The Voter* for updates on some new and interesting convention plans.

**Poll Observer Project** Executive Director Will Hathaway reported on observations gathered at the polls on the November 6 election day. The purpose of the project, which involved both LWVMI members and non-League volunteers, was to gather data on problems and issues with voting. Poll observers were trained by LWVMI Project Director Linda White. Leagues participating were Ann Arbor, Flint, Saginaw, Holland, and Berrien/Cass. See the project results. **Legislative Action** LWVMI took the following action on potential lame duck legislation: HB 5711 (anti-reproductive choice)—opposed; SB 1293 and 1294 (changes regarding BlueCross/Blue Shield) —Michigan Health Consumer Coalition, of which LWVMI is a member, opposed; HB 5408 (Indigent Defense Bill)—supported; bills exempting personal property from taxation without providing adequate replacement revenue for local units of government—opposed. Alice participated in League studies and often took photos of League events, such as canoe trips to study pollution in the Kalamazoo River.

Esther was a Master Gardener and Master Flower Show Judge and was active in garden clubs. She also designed and made quilts. Esther was active in League for many years. # 411 Adds New Dimension to Voter Guide Efforts

year ago, we knew this would be a big election, and it only got bigger as ballot issues competed with candidates for the spotlight. When we received many more calls earlier than usual from individuals asking about the *Voter Guide*, the pressure mounted.

Instead of sticking with our tried-and-true printed *Voter Guide* and online version, we decided it was time to join other Leagues on Vote411.org – the web-based guide that enables voters to view all the familiar content about candidates and ballot issues, as well as check their registration status, find precinct location, and create a ballot they can take to the polls.

The leap was well worth the effort. Aside from a hefty learning curve and some technical challenges, we managed candidate responses that were entered directly into the system and downloaded the content into a format for our printer. From there we relied on our own dependable force of members who helped distribute 28,000 copies of the printed *Guide*.

# **Update on HOMES Coalition**

Affordable housing remains an important issue.



he HOMES Coalition has been in limbo, to some degree since the County Commission refused to put a millage in support the Local Housing Assistance Fund (LHAF) on the ballot. Funding for the LHAF was not part of the County's 2013 budget so the 2012 allocation will be stretched to cover 2013. We still wish to find more permanent funding for the LHAF, but it is apparent that much needs to be done before another request is made to the County Commission. Another request to place a millage on the ballot would have to be made by the Public Housing Commission. In addition, the disillusion of the Affordable Housing Partnership (AHP) during the summer removed a forum for discussing housing in Kalamazoo County. To continue dialogue on affordable housing issues, the HOMES Steering Committee (SC), along with a few others, established Housing Matters. The group meets once a month and has speakers followed by questions and conversation. Call **Ann Perry** at 381-4277 for more information on the next meeting to be held Wednesday, December 12 at noon.

Members of the HOMES SC want to continue the Coalition. The next few months may allow us to determine what the future will bring for the Coalition and its cause.

# Update on Activities of the Poverty Reduction Initiative (PRI)

he Poverty Reduction Initiative has been in a period of transition. We were without a director for several months. **Sherry Thomas-Cloud** served as Interim Director and with our Board chair, **Don Roberts,** and our able Vista volunteers did an excellent job.

A new Director, **Patrick Naswell**, was hired in the fall. Patrick comes to PRI from Flint where he served as vice president of the Community Foundation of Greater Flint, and as assistant to the council to the president at the University of Michigan. In addition, his work with the Charles Stewart Mott Foundation gave him valuable experience in finding community-based solutions to the challenges facing people living in poverty.

In Kalamazoo one of Patrick's first jobs is to keep the PRI solvent. We will soon have a fund drive and, of course, we are always seeking members, donations and grants.

The PRI continues to sponsor a number of programs including Project Connect in November, Poverty Simulations when groups request them, and with local financial organizations, an asset development program for lower income families and individuals called Bank On.
