## LWVKA Adopts Social Media Policy

t the July 17, 2012 Board Meeting, the LWVKA adopted our first Social Media Policy. Social media tools, such as Facebook, Twitter, Pinterest and Youtube have changed the public presence of the League and of its members. This new policy addresses issues that may arise as the League and its members have an increased presence online.

Below is the policy that the Board has adopted. "The Facebook Posting Guidelines" come from LWVUS and will appear in the "about us" section of the LWVKA Facebook page.

## **LWVKA Social Media Policy**

Social media sites such as Facebook, Twitter, Youtube, and Pinterest are tools that the League of Women Voters/Kalamazoo Area may utilize to communicate with our members and the general public. As much as our website and *Bulletins* contain information that speaks for and represents the LWVKA's positions, information posted on any LWVKA social media site should follow already established policies and practices for publications.

The non-partisan policies and guidelines we currently adhere to shall extend to our members' social media presence. For example, the League has a policy that "Board members who hold positions of high public visibility, including the President, *Voter Guide* Editor, and Voter Service Director may not take an active role in a campaign for a political candidate or for a non-League issue. Prohibited activities including hosting and sponsoring campaign events, serving on campaign committees, signing public endorsements, or otherwise publicly demonstrating support." LWVKA members in leadership positions should evaluate what they post on their personal Facebook, Twitter, Youtube or Pinterest pages using this guideline. Actions such as "liking" a candidate on a Facebook page are equivalent to placing a candidate's yard sign in your property or to signing an endorsement petition; these actions become public and may not be reversible.

## **LWVKA Adopts Social Media Policy continued**

Each form of social media, including the LWVKA website, shall have two (2) administrators, of which one administrator must be a current Board member.

The administrators are responsible for monitoring and updating the social media presence of LWVKA, including responding to posts from the public. They are also responsible for deleting posts that do not adhere to posting guidelines (see below). Social media administrators should look to the "Facebook Posting Guide for Local and State Leagues," published by the LWVUS in June 2012.

#### "Facebook Posting Guidelines:" (to be posted on the LWVKA facebook page)

Before we get going, we need to just run through some quick guidelines with you, so we can make sure everyone is having a good time.

- We welcome a diversity of opinions and encourage discussion of the issues on this page. We will be posting news, stories from other Leagues, ways you can get involved and other great information.
- We want to keep our Facebook page an open forum and make sure everyone feels comfortable participating, so please keep comments and wall posts clean and relevant. We reserve the right to remove any posts or comments that fall into the following categories:
- We do not allow graphic, obscene, explicit or racial comments or submissions, nor do we allow comments that are abusive, hateful or intended to defame anyone or any

organization. We will not tolerate any harassment or bullying. In other words, be nice and respectful of others and their opinions.

- We do not allow third party solicitations or advertisements. This includes promotion or endorsements, in addition to attempts to defame or defraud any third-party organizations or groups.
- In order to maintain nonpartisanship, we do not allow endorsement or opposition of political candidates. Posts by others about a candidate are not endorsements or opposition by the League of Women Voters.
- We also do not allow spam. We encourage you to share material with us, but please remain relevant.
- We do not allow comments that suggest or encourage illegal activity.
- You participate at your own risk, taking personal responsibility for your comments, your username and any information provided.

Also, the appearance of external links on this page does not constitute official endorsement on behalf of the League of Women Voters, our chapters or our members.

## LWVMI Position on Redistricting for State Legislature and US House of Representatives

The LWVMI reaffirms its support for the goals of transparency and citizen partnership in the redistricting process.

Recently Leagues across the state participated in the LWVMI redistricting study. The results were sent to the State Board which adopted the following policy at the June 30 Board meeting.

The League of Women Voters of Michigan (LWVMI) supports the formation of an independent redistricting commission in lieu of the legislature as the primary redistricting body. Such a commission should afford equal representative to the major parties and also provide for independent and diverse representation. This commission should be established through legislation and/or a constitutional amendment.

The LWVMI reaffirms its support for the LWVUS goals of transparency and citizen partnership in the redistricting process. To implement these goals the following procedures should be used:

- 1. Meetings of the redistricting body should be subject to the Open Meetings Act.
- 2. Proposed maps should be published in a timely manner, in print, online and on tele-

vision with an explanation of the rationale involved.

- 3. A period of least 30 days following publication of the proposed maps should be allowed for public review and comment.
- 4. Public hearings should be held at different locations throughout the state.
- 5. Census data and relevant census software should be made available online.

The list is open ended. Technological and other improvements should be employed as they become available.

The LWVMI supports population as the primary criterion for redistricting. Other factors of importance are contiguity, maintaining political and geographical boundaries and minority representation. Additional factors to be considered are communities of interest, competiveness and compactness. There should be no preferential treatment for any party and no protection of incumbents. Redistricting should take place only once a decade following the decennial census.

#### Elections: Wins for Voters in Michigan, Arizona and the Nation!

On the eve of the 4th of July, Michigan's governor vetoed voter suppression legislation that would have required ballot affirmation of citizenship, restricted voter registration drives and required photo ID to obtain an absentee ballot. LWVMI and its partners sent a message of thanks to Gov. Rick Snyder. Also, last week, the Supreme Court denied the state of Arizona's request for a stay to block implementation of the 11th Circuit Court of Appeals decision, holding that the documentary proof-of-citizenship requirement for voter registration applicants does violate the NVRA. In other words, we won, at least for now. For more than six years, the League has been fighting against an Arizona law that requires voter registration applicants to provide documentary proof of their citizenship.

## Elections: Voter Purge May Be Coming to Your State Soon

A number of states (including Michigan) have requested access to the federal government's Systematic Alien Verification for Entitlements (SAVE) system which queries other databases for information. It is not clear at this point how up-to -date or accurate the SAVE system is. So its use for purging non-citizens from voter rolls could be problematic, and state systems for identifying and matching possible non-citizens in their databases have been full of errors, most recently in Florida. The League believes that all list maintenance/ removals/purging must be TRANSPARENT, ACCURATE, and LEGAL. To learn more read the <u>recent synopsis from the Advancement Project</u>.

## Supreme Court Upholds Affordable Care Act!

The League issued a statement and posted a blog welcoming the landmark Supreme Court decision

to uphold the Affordable Care Act (ACA). The statement notes that "Leagues throughout the country will continue to educate communities and Americans on the ACA and its pivotal impact on their lives. Health care for all must be the goal as we expand coverage to millions of Americans and preserve the ACA's transformational reforms."

## **Reminder of LWVKA Nonpartisan Policy**

Members must consider the League's nonpartisan policy.

s we approach the election season, it is important to review our Nonpartisan Policy and remember that when we are representing the League at various activities, we need to adhere to the policy.

## Nonpartisan Policy and Guidelines

The purpose of the League of Women Voters is to promote political responsibility through informed and active participation of citizens in government. The LWV is nonpartisan in that it takes positions on selected governmental issues after member study and agreement, but does not support or oppose candidates for elective office (whether or not under a party designation), office holders, or political parties. While the LWV urges its members to be politically active, certain constraints are necessary in order to maintain the nonpartisanship of the organization. The Board of Directors of the LWV has established the following guidelines:

#### Members

Members shall not undertake any activity which may constitute a public statement of partisan position that could be attributed to the League.

Members representing the LWV in the community should be sensitive to their responsibilities. When acting in public as LWV representatives, members must not allow partisanship to be discernible. These members should be fully aware of LWV positions.

Once the LWV (local, state, or national) takes a position on an issue, members may not identify themselves as LWV members in publicly expressing an opinion that is in opposition to a LWV position.

Members may serve on any public board, commission, committee, or coalition; however, that member does not represent the LWV unless officially designated as an LWV representative by the LWV Board. If the appointment is LWV-related, the appointee should be fully aware of LWV positions as they relate to the body's responsibilities.

Members who lead studies should not have conflicts of interest or partisan biases which would affect the objective conduct of information gathering and analysis.

Members in leadership roles at public LWV meetings have the responsibility to ensure the nonpartisanship of the meeting and its environment.

Only petitions approved by the Board of Directors may be circulated at LWV meetings.

The LWV member roster may not be made available for non-League use without Board consent.

## Help Us "Capture the Election" for the Michigan Supreme

Advertising by special interest groups is expected to reach an all time high this year.

project sponsored by LWVMI, "Capture the Election" will monitor, analyze and publicize campaign advertising during this year's election cycle for the Michigan Supreme Court race. The goal of this initiative is to draw media attention to loopholes in campaign finance laws that allow special interests to sponsor election ads without having to disclose their financial supporters

Background: Long before the emergence of SuperPacs, Michigan had experienced an explosion of election spending that is not addressed by campaign finance laws. The Michigan Campaign Finance Network estimates that, from 2000 to 2010, \$70 million was spent that was "completely outside the state's campaign finance reporting system." Undisclosed spending is typically in the form of candidate-focused television ads (i.e., "issue" ads) but also includes literature and robo-calls. In most of the statewide races in 2010, less than half of the funds spent were subject to reporting requirements. Television and print advertising by special interest groups is expected to reach an all-time high during this year's election cycle.

Throughout the election cycle, volunteer team members will collect the campaign literature they receive and record television ads that they observe related to the Michigan Supreme Court election. After the November 6 election, the team will meet and analyze the information collected, using tools provided by the LWVMI.
