STAND UP: PROTECT THE VOTE

The League of Women Voters has always been about voting rights. Our history began with the ratification of the 19th Amendment giving women the right to vote. While millions of women achieved voting rights with that Amendment, millions more continued to be disenfranchised. Women of color were subjected to the same voter suppression measures men of color had endured for years like poll taxes, literacy tests and grandfather clauses. It took another 45 years of organizing and protests against the voter suppression measures before a semblance of full enfranchisement came with the legislative milestone, the 1965 Voting Rights Act.

However, the struggle did not end there as Spanish-speaking and other non-English speaking minorities fought and gained access to bilingual ballots in polling places as enacted in the 1975 extension of the Voting Rights Act. Each of these milestones was a marker in voting rights but not the end of the journey.

Today we are in an era of a voter fraud commission that is working to undermine confidence in elections, claiming millions voted illegally in 2016. Despite no proof, the activities of the commission as well as that of state legislators who continue to target voting rights, are causing more citizens to be disenfranchised. Minority voting is being suppressed through state voter ID laws: reducing early voting, purging voter lists, eliminating polling places and increasing wait times, and even requiring proof of citizenship to register to vote. Voting is a basic building block of democracy and we need to protect it

On **October 16th**, our League is participating in a statewide action to bring together disenfranchised citizens in our community at a forum called, "Stand up: Protect the Vote." Our speaker, **Joan Hunault** from LWVMI, will cover voting rights, voter suppression that lowers turnout, and ways to protect the vote. Local league member, **Alison Parsons**, is organizing this event but she needs volunteers to help make the forum a success. LWVMI Update: Redistricting

The LWVMI Board has been asked why we are not working with Voters Not Politicians (VNP). We hope the following information is useful.

Across the country, other state Leagues have been involved in redistricting ballot proposal campaigns. Each successful campaign was supported by a coalition of organizations that represented the diversity of their state.

Therefore, LWVMI worked for many months with representatives from VNP, NAACP, ACLU and Michigan League for Public Policy (MLPP) to try and form a coalition that could support a redistricting ballot proposal.

On July 17, 2017 the LWVMI Board approved our joining the proposed coalition.

VNP's Leadership Team has not approved its joining the proposed coalition.

Here's what happened as we tried to form the coalition:

- As a part of those meetings, the groups (LWVMI, VNP, NAACP, ACLU and MLPP) negotiated a Memo of Understanding (MOU) that described how the coalition would function. It included criteria for determining which organizations would be represented on the Steering Committee, the responsibilities of the Steering Committee, how decisions would be made, etc.
- Each of the groups' representatives agreed to take the MOU back to our respective organizations for approval so that we could each sign it at our next meeting on July 25, 2017.
- On July 17, 2017, the LWVMI Board authorized President Judy Karandjeff to sign the Memo of Understanding (MOU) which had been negotiated over many weeks by members of the proposed coalition, including VNP.
- On July 25, the groups met to sign the MOU, but VNP didn't have enough votes from their leadership team to sign. At the meeting, Sue Smith and Katie Fahey, President/Treasurer of VNP, agreed to meet on July 28 to discuss what transition steps would need to be taken if the MOU were implemented. It was hoped this transition plan would help to answer some of the VNP Leadership Team's questions.
- On July 28, Sue, Katie and others met to develop a transition plan. During the meeting, Katie agreed to send the proposed coalition members a revised


MOU that the VNP leadership team could agree to, before the groups' next meeting on August 4.

- On August 4, Katie emailed a proposed work plan instead of a revised MOU. The work plan included working on an MOU in the future.
- Meanwhile, VNP had submitted six changes to the ballot proposal they had originally submitted to the Secretary of State on June 24. The June 24 proposal had been prepared by volunteer lawyers based on the ideas of many groups including VNP and the League. The other groups in the proposed coalition were not consulted on any of the subsequent changes.
- On August 4, the other groups concluded that since VNP was not ready to sign an MOU that it would be best to postpone trying to form a coalition. VNP announced its intention to move forward.
- Thus, LWVMI decided to join the proposed coalition, but VNP did not. As Katie stated on the Off the Record TV program, VNP is a "coalition of people."
- LWVMI continues to be committed to forming a coalition that represents the diversity of our state.
- In February 2018, after the ballot proposal petitions are certified, the state Board will decide whether to support the proposal.

Pending Action by US Supreme Court on Gerrymandering


