President's Column

January Program Planning: What is it?

Leagues across the country hold program planning meetings each January. Our program is our agenda for the study of selected governmental issues leading to our positions on these issues as well as our agenda for action to implement the positions after agreement among members is reached. League program is developed at the local, state and national level.

The LWVKA and LWVMI programs to be reviewed in January 2019 include Representative Government, Social Policy and Natural Resources (See the specific positions at the respective websites: www.lwvka.org and www.lwvmi.org).

At our January membership program planning meeting we will review our local and state programs (local and national programs are reviewed in even numbered years) under the leadership of local League volunteers. These volunteers will make proposals for retaining, amending or adding to existing League programs. All members are then invited to discuss the proposals. The resulting suggestions for local program will be considered by the local board that recommends a proposed program. This program is adopted or amended by members at the Annual Meeting in the spring.

Suggestions made for state program will be sent to the state board that formulates a proposed program from suggestions of all local Leagues. Program choices will be made for two years by the delegates at the biennial State Convention in the spring of 2019.

When we consider amending or adding to program we consider the following:

- 1) Is the issue of current importance or is it one community interest could or should be developed?
- 2) Is effective citizen action foreseeable?
- 3) Is the issue important enough to inspire League interest and commitment?
- 4) Is this issue most appropriate for this level of League study and action?

Any amendment or addition to program accepted for consideration by the local or state board would go through the consensus process (See Handbook at lwvka.org). It would be assigned to a study committee that reviews the facts of the issue and encourages the expression of all points of view relative to the issue. A membership meeting would be called to discuss the proposed amendment / addition and a consensus would be required for adoption.

We hope to see you at the Program Planning meeting on January 26th. Best wishes for the holidays!!

Democracy Wins in Michigan!

••This amendment to the Michigan Constitution safeguards our elections and removes barriers to voting.99

Voters on November 6th overwhelmingly approved Proposals 2 and 3, both supported by the League of Women Voters of Michigan and by the tireless efforts of many League members and allies.

Proposal 2 will create an independent citizens commission to conduct redistricting after the 2020 Census. This impartial commission will create district maps for state and congressional offices that cannot favor one party or candidate. The commission will operate in a transparent manner and with extensive public input. For more information, visit votersnotpoliticans.com.

LWVMI in coalition with the ACLU, NAACP and others under the banner "*Promote the Vote*" supported Proposal 3 to ensure that every eligible person can vote and every vote will count. This amendment to the Michigan Constitution safeguards our elections and removes barriers to voting with these provisions:

- Protect the right to vote a secret ballot
- Ensure military service members and overseas voters get their ballots in time for their votes to count
- Provide voters with the option to vote straight party
- Automatically register citizens to vote at the Secretary of State's office unless the citizen declines
- Allow a citizen to register to vote anytime with proof of residency
- Provide all registered voters access to an absentee ballot for any reason
- Ensure the accuracy and integrity of elections by auditing election results

NEWS FLASH!

Online voter registration comes to Michigan! Laws enacted by the legislature and signed by Gov. Snyder at the end of November will make Michigan the 40th state to allow online voter registration. Applicants with a Michigan driver's license or state ID and who have not filed a change of address in the past 10 days will be able to register online. They will have to vote in person the first time they vote for verification of their signatures and information.
