

LWVUS UPDATE

- Campaign for Making Democracy Work (MDW) with special emphasis on protecting voting rights
- Watchdog: Respond strategically on issues with LWV positions when needed, but focus on Campaign for Making Democracy Work.

The LWVUS Board recently created a taskforce to look at the issue of National Popular Vote Interstate Compact. This taskforce will evaluate state league support, assess if enough momentum to warrant national engagement, make recommendations on the likelihood of gaining additional votes to pass the Interstate Compact and suggest plans for LWVUS engagement. This work will be completed by August 15, 2019 for the Board to take action at their fall meeting.

Endowment Fund Investment

Last October the LWVKA Education Fund Board of Directors contacted Vanguard regarding our Endowment Fund Investment in the Life Strategies Moderate Growth fund. It came to our attention that one of the four funds in LSMG, has investment in gun manufacturing. We initially chose our investment because it required little monitoring. LSMG is a fund of funds. However, because of our position on gun control we wanted to change our investment.

We asked Vanguard to consider offering similar options that invested in socially responsible funds that do not support gun manufacturing. Their response was helpful but did not solve our problem completely. They recommended individual socially responsible funds for investment.

The Education Fund Board of Directors voted to move our endowment money to invest in four funds that Vanguard recommended. This means we will need to monitor the investment ourselves. We plan to review our investment quarterly and mirror the asset allocation in the Life Strategies Moderate Growth Fund.

The Education Fund Board wants to consider both, social responsibilities with our investment and no negatively impact our financial return. We appreciate your continued support.


