# President's Column

Gerrymandering, redistricting, politicians selecting their voters...interest is growing in changing Michigan's approach to redrawing the districts from which candidates run for office. This process occurs once every ten years based on figures generated by the Census. As 2020 and the next Census get closer, attention to redistricting will continue to increase.

Some of you will recall that in 2015 the League of Women Voters of Michigan (LWVMI) organized presentations on redistricting at community town hall and civic group meetings. Many of you may have noticed that a group called Count MI Vote in late February this year announced its intention to mount a petition drive to end gerrymandering. Here is an update from the LWVMI about that announcement:

The League supports an independent commission as a solution to the problems with Michigan's current redistricting process. LWVMI is aware that other groups are thinking about a ballot proposal campaign. At this time [2.24.17], the League has not endorsed a ballot proposal or joined a coalition to do so. The LWVMI Board will evaluate the possibility of joining a ballot campaign based on the proposal and the probability of the campaign's success.

LWVMI has already set up additional training on redistricting. Soon more League members will be prepared to raise awareness of just what redistricting is, and how deeply it affects the quality of representative government. Watch the Bulletin for upcoming opportunities to learn more!

# **Equal Pay Day**

Celebrate the 54th year of the Equal Pay Day Act of 1963 on the State Capitol steps in Lansing Tuesday, April 25, 2017 from 12:30m to 1:30 pm. The Equal Pay Act is the federal law amending the Fair Labor Standard. It is the day that women's wages catch up with what men earned the previous week. Red is worn as a symbol of how far women and minorities are "in the red" with their pay. According to 2016 Census data, full time working women in 2015 earned about 80% of the earnings of full time working men.

# **Philanthropy & Public Services**

The Kalamazoo area enjoys two philanthropic phenomena that have different relationships to State funding. The Kalamazoo Promise does not protect the Kalamazoo Public Schools District from decreasing (in real dollars) funding from the State of Michigan. The City of Kalamazoo's Foundation for Excellence, on the other hand, may help the City cope with decreases (actual and real) in local revenue sharing funds from the State.

As an outgrowth of the LWVKA's study of Government Finance in Michigan for the LWV of Michigan, the local study committee organized a forum on the unique use of philanthropic funds for public services in the Kalamazoo area. On March 13, a panel of experts moderated by **Sabrina Pritchett-Evans** explained the differences between the Kalamazoo Promise and Foundation for Excellence to an audience of 25 at the Kalamazoo Public Library.

First, the audience learned about trends in State revenue and expenditures from **Robert Kleine**, Interim Director of the Michigan State University Center for Local Government & Policy. Kleine served as Treasurer for the State of Michigan from 2006-11. He also served the State of Michigan for ten years as Director of the Office of Revenue and Tax Analysis, where he was responsible for state economic and revenue forecasts and development of state tax policy.

Kleine observed that revenue for the State's General Fund and School Aid Fund has increased by 10.6% since 2000; however, over the same period, the inflation rate was 30%. Business taxes as a percentage of all state taxes have dropped since 2000 from 11.5% to 7.6% in 2017. Michigan's business taxes rank among the lowest of the 50 states: 46th as a share of the Gross State Product, and 48th in state and local taxes as a percentage of total taxes for businesses in the state. Michigan's state and local taxes on personal income put our state at 34th of 50 states, below the national average and below the rates of other Midwestern states (2013 figures).

On the expenditure side, Kleine showed the deep cuts the State has made over the period 2001-15 (figures adjusted for inflation): -9.8% in corrections, -10.7% in health and human services, -17.6% in the School Aid Fund, -41.1% in local revenue sharing, and -48.5% in higher education. An additional stress on funding to K-12 school districts has been the State's recent use of School Aid Fund dollars for higher education. With regard to municipalities, the drop in property values during 2008-12 was so steep that most cities will never fully recover their lost tax base. This is because a cap on taxable value increases prevents taxable value from rising rapidly.

**Dr. Michael Rice**, KPS Superintendent, explained how the Kalamazoo Promise cannot protect the school district from the State's declining real investment in K-12 education. The Promise pays tuition for post-secondary education of KPS graduates who attend Michigan institutions. This prospect attracts students to the district. KPS, like other school districts, receives State funding based on the number of students enrolled. More students means more State funding.

However, nearly two thirds of the KPS student population lives with low income or in poverty. It takes more funding to educate students from lower-income families than the State provides. The Promise does not give the school district extra funding. Rice reported that since he came to KPS in 2007, the buying power of the district has decreased by 20%, and the district has made \$10 million in cuts.

Laura Lam, Director of Community Planning & Development for the City of Kalamazoo, described the Foundation for Excellence as one tool among several that the City has deployed to deal with decreases in revenue. Prior to receiving the gifts that constitute the Foundation for Excellence, the City issued bonds to control the costs of pensions, and implemented priority-based budgeting to ensure funding of only the most effective efforts. A panel exploring options for increasing revenue made five recommendations to the City Commission, but even if the Commission had adopted all five, the revenue generated would not have been sufficient to cover expenses.

Philanthropists have given \$70 million to the City, which it will use over the next three years to stabilize the City's budget, reduce the property tax rate for City residents, and to address the aspirations of City residents. The City is conducting a process called "Imagine Kalamazoo" to understand the aspirations of residents. Those aspirations include such things as building sidewalks and removal of lead water pipes, basic items that may not immediately come to mind when one hears the term "aspirations." The City's plan for revenue subsequent to the three-year period is to collect donations for an endowment. An endowment will generate revenue indefinitely. The City welcomes donations of any size for the endowment. Some residents will donate the amount they would have paid in property tax, were it not for the Foundation for Excellence.

Attendees left with a greater understanding of the dynamic and different relationships between state government finance and two local philanthropic efforts — the Kalamazoo Promise and the Foundation for Excellence. Thanks to Government Finance Study committee chair Paula Manley and members Ruth Caputo, Alison Parsons, Kay Perry and Diane Worden for their help with the forum.





# Grand Rapids Unit is Ready to Grow after Redistricting Presentation

Our March 15 Redistricting event at the Cascade Library was a great success with over 100 people in attendance to hear LWVMI President **Judy Karandjeff's** presentation. She shared the following information with us. Every 10 years Michigan districts are redrawn by the legislature. Whichever political party is in the majority would like to retain power and therefore redistricts to maintain this power. This is like putting the fox in charge of the henhouse; it is a conflict of interest. This gerrymandering results in most districts not being competitive, and policies as well as elections are affected. Where the Michigan public would like to see more money spent on education and roads, funding in these areas have actually decreased between 2003 and 2013 after inflation. The League supports changing the process so that it is fair, transparent, and impartial. There is a broad range of policy options, and Karandjeff recommended the Brennan Center's publication: A Citizen's Guide to Redistricting.

# School Groups Challenge \$2.5 Million for Private Schools

LWVMI is a member of the Council of Organizations and Others for Education about Parochiaid. This group is one of ten organizations, including Kalamazoo Public Schools, which are challenging in the Court of Claims recent action by lawmakers to give \$2.5 million to private schools to reimburse for state-required activities like immunizations, background checks and about 40 other activities. The lawsuit claims it is unconstitutional for any taxpayer money to go toward any private school for any purpose. The plaintiffs also claim the reimbursement goes beyond the School Aid Fund provision that allows for reimbursement for "health, safety and welfare" of private school children. Keep your eye on the news for further developments.
