## LAWSUIT UPDATE

LWVMI is lead plaintiff in a federal lawsuit challenging Michigan's Congressional and State Legislative districts as unconstitutional partisan gerrymanders. On March 14, the court ruled not to stay (delay) the proceedings, as the State had requested. Now the court is deciding if LWVMI and the other plaintiffs have standing to sue. ## LWVUS NEWS

Around the nation, LWV is actively “*Defending Democracy and Empowering Voters*” as evidenced by the following:

On **March 20** the US Supreme Court declined to block redrawn Pennsylvania congressional districts from moving forward. The LWV of Pennsylvania had initiated the lawsuit in the summer of 2017 to redraw the district lines. With this decision, the recently redrawn lines remain, and are in effect for the upcoming May primary election. This is a victory for redistricting and ensuring votes count!

The State of Washington legislature passed, and the governor signed bills on **March 19** which include: WA voting rights act, automatic voter registration, same day voting registration, DISCLOSE act, preregistration for 16 and 17-year-olds and post-election audits. Another victory for ensuring voters’ rights!

League members in Kansas recently testified in the federal lawsuit *Fish v. Kobach*, which is challenging the 2013 Kansas state law requiring proof of citizenship when registering to vote. The American Civil Liberties Union filed the lawsuit on behalf of the League of Women Voters and individual Kansans **February 18**. The suit claims that the Kansas law violates the National Voter Registration Act. It is seeking to make the US Court of Appeals preliminary ruling which blocked the law in October 2016 permanent.

### Environmental Update:

LWVUS has joined the Environmental Defense Fund and other organizations to launch and promote the US Clean Energy Progress Map. This map shows the economic impact of clean energy growth across the country. It is a non-partisan, free-to-use public resource which details investments and jobs in the US wind, solar and energy efficient industries. # Observer Corps Reports Proposed By-Law Changes

LWVKA Observers and MerriKay Oleen-Burkey

**Portage City Council** — Regularly scheduled meeting — 10/24/17

*Purpose:* To conduct business for the City of Portage

*Meeting Features:* Two public comment periods; Uses Consent Agenda

*Discussion Issue:* Proliferation of liquor and beer stores

*Possible LWVKA Action:* Land Use Planning

**Oakland Drive/Winchell Neighborhood Association**

(ODWNA) — 11/15/17

*Purpose:* To address issues of the neighborhood common to all residents; to work for the good of the neighborhood; and to constructively assist Kalamazoo City and County Planning Commissions on behalf of the neighborhood

*Meeting Features:* Public comment time; background information available through website

*Discussion Issue:* ODWNA intends to participate with the other 21 City neighborhoods in development of the Kalamazoo City Master Plan. ODWNA to begin work on its submission to the Kalamazoo Planning Commission in February. Process will be about a year long.

*Possible LWVKA Action:* None at this time. Monitor progress.

(ODWNA) — 1/17/18

*Discussion Issue:* Neighborhood plan to be discussed with the residents at the next meeting, a neighborhood open house

*Possible LWVKA Action:* None at this time. Monitor progress.

**Kalamazoo County Board**— Regularly scheduled meeting 1/9/18

*Purpose:* The legislative policy making branch of Kalamazoo County Government

*Meeting Features:* Public comment after the meeting business

*Meeting Business:* Election of Leadership for 2018 — Chairperson Stephanie Moore and Vice Chairperson: Dale Sugars

*Possible LWVKA Action:* None at this time. Monitor Progress.

**Oshtemo Charter Township** Joint Work Session with Planning Commission — 1/25/18

*Purpose:* To conduct business of Oshtemo Charter Township

*Meeting Features:* Public comment was offered at every step of the process

*Meeting Discussion:* Planning Commission presentation to Township Board regarding revisions of the Master Plan required every 5 years.

*Issue:* Balancing commercial growth with preservation of green space and original rural character of the Township

*Possible LWVKA Action:* Observe Township Board which has responsibility for implementing the Master Plan.

**Overall:** Our observers have found that decisions sometimes seem to be made ahead of regularly scheduled council/board meetings. It then appears there is no opportunity for input to those decisions. The earlier observers detect potential issues to monitor, making it more likely for the LWVKA to have an impact on the issues.

## Article V — Officers

**Section 1. Enumeration and Election of Officers.** The Officers of the League of Women Voters of the Kalamazoo Area shall be a President, a First Vice-President (**Vice President/Organization**), a Second Vice-President (**Vice President/Program**) [to clarify the order of VPs], a Secretary, and a Treasurer. The President shall be elected for a term of one year while all other officers shall be elected for a term of two years by the general membership at an Annual Meeting and take office on June 1 following their election. The First Vice-President and the Secretary shall be elected in odd numbered years. The Second Vice-President and the Treasurer shall be elected in even numbered years. No officer shall serve in the same office more than three (3) consecutive terms or six (6) years, whichever is longer.

**Section 5. The Treasurer.** The Treasurer shall collect and receive all monies due. The Treasurer shall be the custodian of these monies, shall deposit them in a bank designated by the Board of Directors, and shall disburse same only upon the order of the Board. The Treasurer shall present statements to the Board at their regular meetings and an annual report at the Annual Meeting. The books shall be audited annually. The Treasurer **or designee** [to allow the Membership Chair to do this task] shall notify each member at least two weeks before the first of the month in which the dues are payable.

## Article VI — Financial Administration

**Section 2. Dues.** Annual dues shall be payable on the first day of the anniversary month of the member's joining the League. Associate members' dues shall be assessed the same as members' dues. Full-time students **and citizens of 60 years and older** [scholarship available for those in need] may pay dues of one-half that amount. Any member who fails to pay dues within three months after they become payable shall be dropped from the membership rolls.

## Article VII — Meetings

**Section 3. Quorum.** At any business meeting of the League of Women Voters of the Kalamazoo Area, twenty-five (25) voting members shall constitute a quorum **at all business meetings of the League of Women Voters of the Kalamazoo Area.** [emphasizes that quorum applies only to business meetings, not all membership meetings]

## Article X — National Convention, and State Convention and Council [obsolete]

**Section 3. State Council.** The Board of Directors at the meeting before the date on which the names of delegates must be sent to the state office shall select delegates to that council in the number allotted to the League of Women Voters of the Kalamazoo Area under the provisions of the By-Laws of the League of Women Voters of Michigan. [obsolete]
