LWVMI Rejects Request to Advocate for GPI

he LWVKA Board recently asked the LWVMI to begin advocating for the development of a genuine progress indicator (GPI) for the State. The GPI would measure the health of our society by looking at progress related to factors such as life expectancy, poverty rates, unemployment rates, disposable income, distribution of wealth, education levels, the state of our natural resources, environmental pollution, human health, and satisfaction with life.

That measurement would be in addition to existing progress indicators like the Gross Domestic Product (GDP) that focuses on the economy by measuring the market value of all final goods and services produced in the State over a given period of time.

The LWVMI is not willing to adopt the project at this time. It is not consistent with their strategic plan. The LWVMI's Advocacy Committee is also concerned about adding to the workload of the state and local Leagues.

LWVKA Supports Countywide Transit Millage

Public transit provides a valuable community service.

n the May 7, 2013 ballot, voters in Kalamazoo County will have the opportunity to vote on a 0.4 mills renewal question supporting public transit services. The question reads:

"The Kalamazoo County Transportation Authority, County of Kalamazoo, Michigan was formed to operate and provide public transportation within the County of Kalamazoo and seeks renewal of previous authorization from the electors to levy up to 0.4 mills for this purpose. Accordingly, for the purpose of providing public transportation services within Kalamazoo County, shall the limitation on the amount of taxes which may be imposed on taxable property in Kalamazoo County be continued at 0.4 mills, being 40 cents (\$0.40) per thousand dollars (\$1,000) of taxable value on all taxable property in Kalamazoo County for a period of four (4) years, 2013, 2014, 2015 and 2016. It is estimated that 0.4 mills would raise \$3,089,900 in the first year."

The LWVKA Board voted at its March meeting to support the countywide transit millage question. The League of Women Voters supports public service delivery systems that are in the best interests of the community as a whole, feasible to implement and accountable to residents, includ-

ing transportation systems that afford better access to housing and jobs.

Relevant facts about public transportation in Kalamazoo County include:

- This millage will raise 18% of the operating budget for public transit
- 73% of riders have no other means of transportation
- 65% of trips are taking passengers to or from work and school
- Ridership is up 9% over the previous year
- 2.9 million trips were taken on fixed route service in urbanized area of county in 2012
- 133,456 trips on Metro County Connect, the countywide demand/response service in 2012

LWVUS Board Outlines Approach to Proposals Regarding Money in Politics

The LWVUS, at its Board meeting on April 7, adopted a statement regarding forthcoming proposals for work on issues related to money in politics. This statement is intended to clarify the stance the League is taking on such proposals going forward. In addition, LWVUS is establishing a Campaign Finance Task Force. Over the next few months, the task force will be developing a discussion guide and evaluating constitutional and legislative proposals.

League Expresses Support for Wind Energy

The League joined members of the environmental community by sending a letter to the U.S. House of Representatives expressing strong support for H.R. 924. This bill extends the Investment Tax Credit for offshore wind and encourages investment in the growing industry.

League Comments on Contraceptive Coverage under Affordable Care Act

The League joined with other organizations concerned about women's reproductive health in submitting comments on regulations proposed by the Department of Health and Human Service (HHS) regarding preventive services under the Affordable Care Act (ACA). The comments urge HHS to keep the religious exemption narrow in order to protect access to preventative care such as contraceptive coverage. The comments note that under the ACA, the regulations must provide seamless contraceptive coverage with no cost sharing for women.

League Joins "All Risk, No **Reward Coalition" on Keystone XL Pipeline**

LWVUS and LWV Nebraska joined the "All Risk, No Reward Coalition" on the Keystone XL (KXL) Pipeline. The coalition will be working in the coming weeks to encourage President Obama and the State Department to reject the permit for the proposed KXL Pipeline. LWVUS sends letter to U.S. **Senate on Immigration Reform**

The League sent a letter to the U. S. Senate on April 18 regarding immigration reform and citizenship in a democracy. The League is urging Senators to ensure that a path to citizenship is available to all who remain le-
