Signatures still needed! Signature gathering to protect and enhance voting rights in Michigan is going well as of May. June marks the final push of this collective effort of the League of Women Voters, ACLU and NAACP. Please step up, if you can, to collect a few signatures. Ask your family and friends—every single signature helps!

An EPIC-MRA poll from May shows that of Michigan voters likely to vote in November, 77% would vote for Promote the Vote—if it were on the ballot! LWVKA's 30 volunteers have gathered 1,200 signatures since February. Reinforcements would be welcome!

Redistricting Ballot Proposal

The **Voters Not Politicians** redistricting ballot proposal may make it on to the November ballot! LWVMI has endorsed this proposal and urges League members to support the measure in any way they can.

Gerrymandering Lawsuit

LWVMI is lead plaintiff in a federal lawsuit challenging Michigan's Congressional and State Legislative districts as unconstitutional partisan gerrymanders. The defendant, Michigan Secretary of State **Ruth Johnson**, asked the court to dismiss the lawsuit, claiming the League and other plaintiffs lack standing to sue.

On **May 16** the court granted the Secretary of State's motion to dismiss for lack of standing in part and denied it in part, dismissing the plaintiffs' statewide claims but holding that the plaintiffs have standing to bring district-specific claims. The trial is set to begin on February 5, 2019.

- Ohio voters approved a ballot issue in their May primary to create new rules for drawing congressional lines. On May 23rd the LWV of Ohio joined in a lawsuit challenging the state's U. S. congressional districts as unconstitutional. While the passage of the ballot issue will create fair maps beginning in 2021, this lawsuit addresses creating fair maps for the 2020 elections.
- The House Oversight and Government Reform Committee held hearings on the proposed inclusion of the citizenships question on the 2020 Census. This question has not been on a census form since 1950.
- ✿ The LWV of Missouri and A. Phillip Randolph Institute recently filed a lawsuit against the state of Missouri for violation of the National Voter Registration Act. The suit alleges the state does not offer all residents the option to register at state motor vehicle agencies or to have their voter registration information automatically updated when residents notify the state they have moved.

Annual Meeting Highlights

Our LWVKA Annual Meeting on April 30th opened with a tribute to long-time member **Ann Perry**. Michigan State Representative Jon Hoadley presented a commemorative plaque to Ann's sisters, **Kay Perry** and **Sue Nelmes**, which had been signed by all of her state elected officials. It acknowledged Ann's lifetime of com-

munity service to the citizens of Kalamazoo.

The keynote speaker for the evening was **Judy Karandjeff**, President of LWVMI, who discussed the three forms of advocacy being used by the state League: 1) Action Alerts—They request that individual League members around the state contact their members of the state legislature when proposed bills deal with top-



ics on which the League has positions; 2) Lawsuits such as the current federal lawsuit LWVMI vs. Johnson in which the LWVMI is lead plaintiff in the redistricting case; and 3) Ballot petitions like the Promote the Vote ballot initiative to amend the Michigan Constitution to make voting more accessible and convenient.

During the business meeting the 2018-2019 General Fund Budget was approved, proposed by-laws changes were adopted, and nominees for the LWVKA board were elected. The meeting closed with an informative presentation by Janet Jones on the County ID program that was being launched at the County Building on May 3rd.

Diane Worden won the raffle for Ann Perry's suffragette doll. Proceeds from the raffle were donated to the LWVKA in Ann's memory.
