President's Column

LWVMI Convention: Delegates' Perspectives

The 100th Anniversary of the League of Women Voters of Michigan (LWVMI) was celebrated at the State League convention May 17–19. The convention offered outstanding speakers on a variety of topics relevant to the work of our state and local Leagues. Since we had several first-time as well as seasoned delegates at convention, they have been invited to share their perspectives on what they heard:

As a first-time delegate to a LWV State Convention, **Fran Eckenrode** was impressed with a constant theme: The League is driven by its Program. "Early in my League membership, I did not appreciate that the 'Program' went beyond the yearly January meeting to review and suggest revisions. At convention, I was impressed that the Program drives all that we do in the League from voter registration to Vote411 to forums and environmental advocacy. In her Sunday remarks, outgoing president **Judy Karandjeff** reviewed achievements in each state position. It was an impressive list. The recipients of the Bell Ringer awards each demonstrated activities and accomplishments in different areas of the Program. The Friday afternoon update on the Redistricting Lawsuit was an impressive example of advocating for Voting Rights."

First-time LWVMI State Convention attendee, Jules Isenberg-Wedel found the information shared as well as the networking opportunities with other League members to be very valuable. Jules said, "The plenary sessions were very helpful to my understanding of the dynamics of the relationships between the Local, State, and National Leagues. The Plenary Sessions went through the business proceedings of adopting proposed bylaw amendments, budgets for FYs 2020 and 2021, electing State Board Members and Officers, and the adoption of the State Program. Specific to the State Program, it was unanimously supported that LWVMI undertake a new study on the structure and process of the Michigan Legislature limited to exploring the ramifications on democracy, if any, posed by lame duck sessions and developing guidelines, if warranted, regarding the type of bills and how such bills should be handled in a lame duck session." Jules was impressed by many of the speakers and mentioned in particular, "LWVMI History Talk" — Judy Karandjeff and Deborah Bunkley interviewing Kathleen Straus & Diana Rockall; and Keynote Speaker Elaine Weiss, author of The Woman's Hour: The Great Fight to Win the Vote. "It affirmed not only the vital importance of the ongoing and evolving work conducted by local leagues, but celebrated the rich history that has brought us to where we are. I look forward to attending future Conventions and encourage other members to do so as well in 2021!"

Courtney Winell was also a first-time convention attendee and she found the Local League Basics Workshop of particular value. Courtney said, "It was nice to have several presenters who spoke on their areas of expertise. I especially liked the breakout portion at the end of that session where we had an opportunity to work with a presenter of our choice to find out additional information and ask questions." Courtney also found valuable opportunities to network with other Leagues as well as geographical units that are going through the same process as the Grand Rapids unit to become a MAL.

LWVUS UPDATE

May 21, 2019 marked 100 years since the U.S. House passed the 19th Amendment. June 4th is the 100th anniversary of the U.S. Senate approval of the 19th Amendment.

LWVUS is championing HR 1923 Women's History and Nineteenth Amendment Centennial Quarter Dollar Coin Program Act to honor inspirational women on state quarters. One side will feature 19th Amendment icons and the other side a noteworthy woman selected by each state and U.S. territory.

On May 15th LWVUS joined over 400 organization including voting rights, civil rights, faith, environmental, labor and grass roots groups on letters sent to all announced presidential candidates. They asked the candidates to implement a democracy reform plan.

LWVUS recently endorsed the Protecting American Votes and Elections (PAVE) Act introduced by Senator Ron Wyden. This act would protect elections from foreign interference by mandating hand marked paper ballots and new cybersecurity standards for all federal elections.

Delegates' Perspectives, Continued

Denise Hartsough, a seasoned convention attendee, noted: "Convention delegates heard from inspiring women leaders — LWVUS President Chris Carson, Rep. Rashida Tlaib, and former State Board of Education member Kathleen Straus. Vice President for Advocacy Joan Hunault imparted her wisdom in the League Basics workshop, pointing out that advocacy is an ART. It involves Affection for the governmental process and for one's community, Relationships with elected and appointed officials, and the Tenacity to overcome setbacks and to play the 'long game."

Yolanda Mitts has attended a few State conventions in the past but she found this one of special interest because of its historical context. She noted "a wonderful historical display greeted us at the convention room depicting the struggles of our courageous predecessors who got women the right to vote. Like the struggle for passage of the Nineteenth Amendment, it is taking decades to achieve passage of the Equal Rights Amendment (ERA) too." A workshop was offered on the status of the ERA where Laura Callow, LWV-NW Wayne County, who has devoted a great deal of time to the ERA, gave an impassioned presentation. Ratification by one more state is needed for the ERA; there's a glimmer of hope in Virginia that might take it to the finish line.

Jessica Reiser, also a seasoned convention attendee, offered additional thoughts about the ERA Workshop: It began with an ERA time line that began in 1923 when Alice Paul introduced ERA into Congress and continued to the present. Clarification on Redistricting from the May Bulletin

We received some questions about the articles on redistricting in the May Bulletin, and we want to offer a better explanation.

There are two separate redistricting initiatives. On page 2 of the May Bulletin we shared the good news that the lawsuit that LWVMI has been engaged in to have district maps redrawn before the 2020 election due to illegal gerrymandering was decided in their favor. Although that case has been appealed and we don't know what that will do to the timeline, currently the lawsuit requires 34 districts be redrawn and these new districts would be used in the 2020 election.

The other initiative is the Voters Not Politicians 2018 Ballot Measure #2 that will turn redistricting over to an independent commission. That commission will not be operational until after the 2020 census but the two articles in our May Bulletin tell about the implementation of the commission. Later this year, citizens of Michigan will be invited to apply to be on the commission. It will be finalized by 9/1/2020 and will begin meeting in October 2020. The new districts that come from the commission will not be used until the 2022 election.

Implementation of Proposal 3 Initiatives

On April 4th, 2019, the Election Administration Committee had a meeting with Deputy Clerk Shelby Moss to discuss the implementation of the Proposal 3 initiatives. Shelby was very informative and is working hard with the state of Michigan to insure the new requirements from the proposal are implemented in a timely fashion. The following topics were discussed and recorded.

Senate Bill 1238, PA 603 shaped the implementation of Proposal 3. This law determined that voter registration on Election Day will take place in the clerk's office. This change will make the provisional ballot all but obsolete. This law also created the 15-day voter registration deadline instead of 30 days. The postmark for the voter registration must be 15 days before the election. From day 14 before the election through Election Day, any qualified elector who wishes to register to vote must do so at their clerk's office in person. (Note: this can happen only at the local clerk's office of the jurisdiction where the voter currently lives.) The qualified elector must provide photo ID (or sign an affidavit) and proof of residency.

- If the MI Driver's License or MI Personal ID contains the voter's current address, no other proof of residency is required. If the photo ID provided is not a MI Driver's License or Personal ID Card, or if the ID provided does not contain the voter's current address, additional proof of residency is required.
- Documents that may be accepted for proof of residency (these items must include the applicant's name and current address):
- a current utility bill
- bank statement
- paycheck
- government check
- other government document.

WMU has created a standing committee—We Vote— to help with on campus voter registration and voter education. LWVKA works with this committee. Students need to be aware that whatever the address is on their driver's license or state ID is where they are registered to vote. Students may need to make arrangements for an absentee ballot if necessary. Voter registration will happen automatically now when you get a Michigan driver's license or state ID. With the new law, if the student is a first-time voter, they can send in their voter registration and request for an absentee ballot at the same time. The requirement that persons registering to vote by mail must vote in person the first time no longer applies. The State of Michigan is working on the online voter registration application and it will be up and working as soon as possible.

The Federal ID law is still in place. Potential voters who register by mail must accurately enter their state issued driver's license or personal ID number or the last four digits of their Social Security num-

ber on the mail-in voter registration form. Alternatively, the voter may send one of the following forms of identification when mailing the mail-in voter registration form to their county or local clerk: a copy of any current and valid photo identification or a copy of a paycheck, government check, utility bill, bank statement or government document which lists their name and address. If a voter registering by mail does not meet the requirement when registering, the voter must present one of the above listed documents before being issued a ballot at the first election in which they wish to participate. The federal identification requirement does not apply if: the voter hand delivers their mail-in registration form to the county or local clerk's office; the voter is disabled; or the voter is eligible to vote under the Uniformed and Overseas Citizens Absentee Voting Act.

No reason absentee voting is in place and functioning. Absentee ballot requests can be submitted by mail, email or fax. These requests must have a signature on them. These requests (with signatures) can be scanned or sent via email as a picture attachment. The deadline for mailing absentee ballots to voters has changed to 5:00pm the Friday before Election Day. If the clerk's office receives an absentee ballot request on the Saturday before the election they will make an effort to contact the voter and instruct the voter to come to the clerk's office in order to receive an absentee ballot. The clerk's office will be open on Saturday before Election Day from 8-4 for voter registration and absentee voting.

The State of Michigan is designing a reporting system that establishes links to prevent citizens from voting in 2 places on Election Day. This report will reconcile any double voting situations, and prosecution is possible.

Several instances of the clerk's office helping citizens get to vote in extraordinary situations were discussed. We are very proud of how the Clerk's Office conducts business here in Kalamazoo and we are grateful that election administration is a full-time job and focus for the Deputy Clerk.

City Clerk Scott Borling and Deputy Clerk Shelby Moss presented at the 2019 Master's Academy of the Michigan Association of Municipal Clerks on Risk Limiting Audits for election results. Risk-limiting audits involve manually examining some, or all, of the paper ballots validly cast in a contest. Statistical sampling techniques are used to ensure that ballots were counted accurately. A risk-limiting audit ensures that the hardware, software, and procedures used to tally votes found the real winners.



Annual Meeting High- lights

This year's Annual Meeting was held at Niko's Landing in Comstock, on April 29th with sixty-five people attending.

The keynote speaker was Dr. Denise Keele, Associate Professor of Political Science and Environmental and Sustainability Studies at WMU. Dr. Keele gave a very informative presentation on the 'Big Picture of Environmental Politics', beginning with an overview of environmental politics, and describing major issues and the political challenges and possibilities for addressing them. Her talk spanned the time from landmark publications such as Rachel Carson's 1962 book, *The Silent Spring*, and Ken Boulding's The Economics of Spaceship Earth, to strategies currently under consideration such as the Energy Innovation and Carbon Dividend Act and the Green New Deal Resolution. She discussed reasons that particular strategies might or might not appeal to people with either conservative or liberal leanings, and suggested ways to move forward together. Her talk was followed by a lively discussion.

During the business meeting, the 2019-2020 General Fund Budget was approved and the by-laws were adopted with no changes. The Local Program was adopted with no changes. Nominees for the LWVKA board were elected. President MerriKay Oleen-Burkey summarized the work of the League during the year and recognized the many volunteers an initiatives including voter registration and education, Ballot Proposal petition work, candidate forums and mock elections. The Grand Rapids unit's great work on voter registration was noted.

MerriKay ended by inviting those interested in joining the Centenary Committee for the League's anniversary in 2020 to contact Fran Eckenrode.


