LWVUS Convention 2012–Wow!

aula Manley and Connie Ferguson joined more than 800 Leaguers who attended the 50th Biennial National Convention June 8-12 in Washington, D.C. The League celebrated accomplishments on campaign finance reform, the environment and election reform, and discussed important public policy issues.

We elected a new Board, including Michigan's Pat Donath as Secretary-Treasurer. About half the Board will be new to that role. In her acceptance speech, the League's reelected president Elisabeth MacNamara challenged delegates: "The League is not an end in itself. We are a training ground for democracy. That is what we have always been and that is what we will always be, working together to learn new ways to spread the word and encourage new generations to learn and engage."

The new budget includes a \$1 increase in the per-member payment to \$31. This money helps support the Washington office and the activities of the National Board and committees. It also serves as seed money for additional fund-raising activities.

The League's "Power the Vote" initiative for elections work was the theme of the convention. Speakers, including U.S. Attorney General Eric Holder, Trevor Potter, President of the Campaign Legal Center, Former Congressman Mickey Edwards (R-OK) and political reporter Eleanor Clift, urged the League to look closely at the steps needed to fix the broken campaign finance system, to press forward using our community-based power on behalf of all voters, and to work for elections that are determined by the voters. Pollster John Zogby and The Capitol Steps comedy team added their perspectives on this and other political topics.

Program discussion was lively. We adopted a concurrence with the Washington, D.C, League position on Sentencing Policy: The LWVUS believes alternatives to imprisonment should be explored and utilized, taking into consideration the circumstances and nature of the crime. The LWVUS opposes mandatory minimum sentences for drug offenses.

In addition, we decided to review and update our agriculture position, adopted in 1988. We will look at genetic modification, consolidation in the food industry, money in the regulatory process. and the consumer's right to accurate and comprehensive food labeling.

An adopted resolution on campaign finance reform calls upon the LWVUS Board to advocate strongly for all appropriate dulyconsidered measures which may include, but are not limited to, a constitutional amendment, and which are consistent with our current positions on campaign finance reform and individual liberties; allow Congress and the States to set reasonable regulations on campaign contributions and expenditures; and ensure that elections are determined by the voters.

Five Michigan delegates including Connie and Paula visited Capitol Hill after the Convention was adjourned. We met with staff of Senators Levin and Stabenow to thank them for co-sponsoring the DISCLOSE Act and to ask how we might assist in getting it passed.

Public Education Focus of Annual Meeting

Members learn of challenges facing public education.

n April 17, 2012, LWVKA members and friends gathered at the Park Club in Kalamazoo for the Annual Meeting. After social time and dinner, keynote speaker **Ron Fuller** offered an address on "The Future of Public Education in Kalamazoo County." Fuller, who has served for 38 years in public education, is currently the superintendent of Kalamazoo RESA, the intermediate school district.

Fuller believes that education, like police and fire protection, is a public service that government should sustain and not privatize. He shared a graph that contrasts the 15% rise in inflation since 2005 with the decrease of 1% in per pupil funding since 2005. The gap of 16 percentage points is exacerbated by the 27% increase since 2000 in the contribution for retirement that school districts must pay.

The major cost for school districts is staffing, but not because teachers are making high salaries. A beginning teacher in our geographic area earns \$34,000/year. If the teacher has two children and a spouse at home, the children qualify for free/reduced lunch.

Fuller sees great potential for advancement in public education, given new and varied approaches that include online learning and other technology. He also noted the merits of consolidated services. Kalamazoo RESA, for example, performs "back office" functions for six school districts, handles common bids for buses and fuel, and provides technical services for districts from Indiana to Michigan's Upper Peninsula.

Fuller is concerned, however, that the State of Michigan is increasingly allowing entities other than public school districts to obtain public per-pupil funding. Charter schools, many of which are for-profit, spend less on teachers and more on administration than do traditional public schools. Yet, according to a Stanford study of sixteen states, charter school students perform the same as or worse than do traditional schools' students. Online schools that match several hundred students to one teacher offer even more opportunity for profit-making that may come at the expense of sound education. Vouchers that families could use in any public or private school, in Fuller's view, would result in segregation by income and race.

Following Fuller's address, the LWVKA conducted its Annual Business Meeting. Members reviewed and accepted minutes, budgets and reports on the local program and bylaws. Members also nominated and elected candidates for positions as officers, directors and Board members.

Co-President **Paula Manley** recognized **Connie Ferguson** for selection as a Ruth S. Shur Fellow by the LWVUS, and several members in attendance for membership of fifty years or more. Manley highlighted LWVKA accomplishments of the previous year and opportunities for participation during the coming year. Opportunities include support for candidate forums, voter guides, voter registration and the student voting project.



News From National and State



LWVUS: Big Win for Voting Rights! The April 17 landmark 9-2 decision by the

Court of Appeals for the Ninth Circuit in the case *Gonzalez v. Arizona*, ruling Arizona's Proof-of-Citizenship requirement violates the National Voter Registration Act (NVRA), is a huge win for voting rights. The Ninth Circuit dealt a blow to attempts to add requirements to the voting process that are unnecessary and will disenfranchise eligible voters. At stake was Arizona's Proposition 200 which required voters to produce proof of citizenship when registering to vote using the federal mail-in registration form. The League was a plaintiff in the case.

Voter Protection Debate Nationwide & in the Halls of Congress

The American Legislative Exchange Council (ALEC) announced in April that it is discontinuing its Public Safety and Elections Task Force, which is responsible for the promotion of 'model' voter identification and stand-yourground legislation. This came after many organizations pressured corporations to withdraw their support from ALEC. Also, the League weighed in at the House Committee on the Judiciary April hearing examining the Department of Justice's record on voting rights enforcement. We asked why the Judiciary committee held this hearing rather than taking on the anti-voter laws that were hastily passed in so many states around the country.

Campaign Finance Task Force

A new League *Campaign Finance Task Force* is now hard at work. It includes nine knowledgeable and committed League members, including Michigan's **Pat Donath**. The Task Force will serve as a resource to the LWVUS Board and will provide information and input on campaign finance issues, including short- and long- term strategies for reform. They have just completed two informational papers for League members: "LWVUS in Action on Campaign Finance," a brief history of LWVUS action on campaign finance, and a <u>"Review of Constitutional</u> <u>Amendments Proposed in Response to *Citizens'* <u>United</u>," which includes a useful table of the proposed amendments and what they address.</u>

Opposition to S. 1100: The League joined other civic organizations in a <u>letter to Senators</u> <u>Collins and Lieberman</u> voicing solid opposition to the "Keeping Politics Out of Federal Contracting Act." This bill would block public disclosure of campaign contributions and spending by government contractors. Contractor campaign spending would be kept in the shadows, and the public would have no way to find out if contracts are being awarded based on money rather than merit.

The 2011 Annual Report for the League of Women Voters of the U.S. and the League of Women Voters Education Fund is now available. The Report highlights our programmatic activities throughout the calendar year, while the Financial Report covers our fiscal year from July 1, 2010 to June 30, 2011. We produce the Report to highlight League activities and accomplishments for the national League's current and prospective funders, friends and partner groups.

League Year in Review

LWVKA had an active, successful year.

he LWVKA had a busy year from July, 2011 to June, 2012. Our biggest effort is voter registration under the capable leadership of **Karen Eddy**. Throughout the year a League volunteer was at the local Department of Human Services office each week. We had voter registration tables at community events such as Kalamazoo Pride Festival, Mothers of Hope, Bronco Bash, and Kalamazoo Valley Community College.

August 26 was the annual Women's Equality Day luncheon program at the YWCA. In September we held our first fall meeting at the Ladies' Library Association. **Terry Hluchyi** led us in learning about Civil Discourse using the topic of privatization of government services. Also in September our *Bulletin* was offered via email to members.

During October we were busy with voter service activities under the leadership of **Terry Hluchyi** and **KC Miller**. We held a Kalamazoo City Commission Candidates Forum and posted the two-minute candidate introductions on our website. We responded to a request from citizens of the City of Allegan to hold a candidates forum as they have no League in their community. We offered our *Voter Guide* information both online and in print.

During the year, we conducted two national studies and one state study. **Denise Hartsough** led the national study on the "Role of Government in Federal Education" with a consensus meeting in November. **Michele McGowen** led the national study on "Privatization of Government Services" and held the consensus meeting in April. The state study on redistricting was completed at the end of May, and **Paula Manley** led us at that consensus meeting.

Our Annual Meeting was April 17 and featured KRESA Superintendent **Ron Fuller** as the keynote speaker. He gave us his view of the future of education in Kalamazoo County. In early June, the League assisted *MLive/Gazette* and WMUK with the 6th District House of Representatives primary race debate between candidates **Fred Upton** and **Jack Hogendyk**.

The League submitted letters to the editor and a viewpoint article to the *Kalamazoo Gazette* during the year. **Carol Urban** wrote about elections and civility, **Michele McGowen** submitted one about contraception issues. **Connie Ferguson** and **Paula Manley** submitted an article about climate change and clean air, with the assistance of **Jessica Reiser** and LWVMI Natural Resources Chair **Suzanne Dixon**.

Connie Ferguson was selected by the National League as a Ruth Shur Fellow. She will be working with other Shur Fellows on building League leadership and best practices with local and state Leagues around the country.

As members of the Kalamazoo Environmental Council, we assisted with a series of education forums, as well as the annual legislative breakfast. **Ruth Caputo** continues to serve as the Michigan alternate to the Lake Michigan League of Women Voters. We worked with the LWVMI to publicize the Clean Air Promise.

The Tax Attitude Group still meets faithfully each month. They are meeting with groups to explore ways to get the message out about the benefits we citizens receive from our tax dollars.

We could not accomplish all of the above without the support and hard work of many League volunteers. Thank you to all who helped to make this another successful League year!

Voter Service Update

LWVKA gears up for fall elections.

WVKA assisted the *Kalamazoo Gazette* and WMUK with a Candidate Forum for the 6th District Congressional Representative primary race on June 10 at WMU. Two hundred people attended the forum with **Jack Hoogendyk** and **Fred Upton**. There may be another 6th Congressional District forum prior to the November general election.

The Kalamazoo County Advocates for Senior Issues (KCASI) and LWVKA are planning to partner for forums this fall. An educational offering about the Michigan Supreme Court Justice election is one possibility.

The *Voter Guide* for the primary will be online July 2, 2012 and in print no later than July 8, 2012. The contested races are US Senate, US House of Representatives, Kalamazoo County Sheriff, and four County Commission districts. This election will reflect the redistricting for the state and counties. Check the Kalamazoo County web site for the district map or the Kalamazoo County Candidate Instructional Manual.
