President's Column

Reaching the Underrepresented

Earlier this year the League of Women Voters of the Kalamazoo Area (LWVKA) received a grant from the LWVUS Education Fund for a voter registration drive targeting underrepresented communities of students. Eight LWVKA volunteers participated in voter registration events between January and March at five locations: Kalamazoo Central High School, Loy Norrix High School, Phoenix Alternative High School, KAMSC, and Kalamazoo Valley Community College (KVCC).

The schools were chosen because of the proportion of minority enrollment, ranging from 30% at KVCC to 87% at Phoenix Alternative High School, as well as the proportion of economically disadvantaged students. In the past seven years, Kalamazoo Public Schools averaged 69% of students eligible for free or reduced price lunch, a measure of the economically disadvantaged in this urban district compared to 47% statewide.

Our collaboration with the school administration made these voter registration events our most successful to date. We encountered over 140 students. A few were already registered to vote or were not yet citizens but 134 completed voter registration applications. At each event the students could view a sample ballot for the May election or received the website link to the ballot. Eighty of the new registrants were eligible to vote in May. Two weeks before the May 2nd election, vote reminder postcards were mailed to these newly eligible voters.

While the results of this voter registration project far exceeded, in numbers of newly registered voters and what we had achieved in previous years, LWVUSEF has shared some innovative ways to work with school districts. We will have the opportunity to try these ways when we return to these schools for voter registration in the winter/spring of 2018.

Voter registration is, of course, only the first step in getting young people and other underrepresented individuals such as communities of color and individuals with low incomes to exercise their right to vote. How do we prevent the disenfranchisement of these eligible citizens?

What's Ahead? This fall our League has the opportunity to collaborate with the LWVMIEF on a project targeting an underrepresented part of our community. We need to identify a local organization partner that serves the underrepresented and together plan a program that will focus on why it is important for them to vote, what the current voting laws are, what may be suppressing their votes, and what changes, such as early voting, could make it easier to vote. Program participants will be given the means of contacting their elected officials about voting changes they would support. A get-out-the vote plan for the November election in this underrepresented community will be a part of the project as well.

Redistricting Ballot Proposal Update

Statement from the League of Women Voters of Michigan (LWVMI) as of July 24th

LWVMI has been talking with a number of organizations including Count MI Vote, which also does business as Voters Not Politicians.

Count MI Vote filed a ballot committee with Michigan's Secretary of State on February 24, 2017. The League of Women Voters of Michigan has not filed a ballot committee. Michigan's Campaign Finance Law governs the activities of ballot committees as well as those organizations that have not filed a committee.

Count MI Vote (CMV) submitted petition language at the end of June to the Bureau of Elections. Since then, CMV has submitted several changes to the language. The Bureau of Elections is continuing to review the constitutional changes proposed by CMV's petition. Once that review is complete, the Board of State Canvassers will meet to review the form of the petition language. Until that happens, CMV will not print the petitions.

Meanwhile, LWVMI continues to meet with a number of organizations in an effort to form a coalition. An agreement has not been reached yet. Negotiations continue. In our opinion, there must be a viable coalition that supports an agreed upon proposal in order for a campaign to be successful.

Since the League of Women Voters of Michigan has not signed a Memo of Understanding with a coalition, local Leagues cannot participate in CMV activities. Individual League members may participate in CMV activities as individuals, but not as League members.

Our goal continues to be one viable coalition supporting one agreed upon proposal. We will continue to work on this issue on your behalf and will let you know of any changes, as soon as possible.

Women's History Exhibit: "Petticoat Patriots"

"Petticoat Patriots: How Michigan Women Won the Vote" highlights events during the 75-year fight for women's suffrage. The exhibit shares the stories of more than 20 women who helped win the vote, including three from the Kalamazoo area: Olympia Brown, Caroline Bartlett Crane and Lucinda Hinsdale Stone.

Created by the Michigan Women's Historical Center & Hall of Fame, the exhibit features 18 panels. The exciting and inspirational story starts with the abolitionist and Quaker women who began to call for women's rights, to the first Women's Rights Convention in Seneca Falls, New York in 1848, and through the final passage of the 19th Amendment granting women the right to vote in 1920.

LWVKA has partnered with the Ladies' Library Association (LLA) to bring "*Petticoat Patriots*" to Kalamazoo. LWVKA's Education Fund is providing financial support, as is the Kalamazoo Community Foundation and Ladies' Library Association. LWVKA members have volunteered to work shifts as hosts during the exhibit at the LLA's historic building, 333 S. Park Street. Parking is available in the LLA lot at the corner of S. Park and Lovell Streets, next to St. Luke's. Both the exhibit and parking are free.

The exhibit will be open to the public from September 12th-19th, weekdays from noon-7:30 pm; Saturday, 10 am-5 pm; and Sunday, 1-5 pm. LWVKA members and friends are invited to gather for a private viewing of the exhibit on Wednesday, September 20, 3-6pm, 333 S. Park Street.

GR Unit Updates



What is the League of Women Voters Education Fund?

The League of Women Voters of the Kalamazoo Area maintains two legal entities to carry out our mission. Each entity has a separate board. LWVKA is a 501(c)4 organization, which means that contributions are not tax deductible. Members cannot deduct dues on his/her income taxes as a charitable contribution because the League is established as a lobbying organization.

The League of Women Voters of the Kalamazoo Area also maintains an education fund (LWVKAEF). We are very fortunate to have our own fund because it is a 501(c)3 organization, which means that contributions to it are tax-deductible for the donor. It is through this side of the League that voter information and citizen education activities are funded.

The Internal Revenue Service has developed detailed regulations on tax-deductible and non-tax-deductible contributions. There are reporting requirements and restrictions on certain activities that are funded with tax-deductible monies. Voters' guides and candidate debate activities are reviewed to ensure that they do not give the impression of favoring any particular candidate. Questions should be unbiased, even on issues where the League has a position, so as to not reflect or suggest a bias or preference for or against any candidate's views. Events exhibiting even an unintentional bias may jeopardize the League's tax-exempt status.

LWVKAED currently has a seven member board. The members are **Paula Aldridge**, **Susan Atkinson**, **Dennis Elmer**, **Rebekah Fennell**, **Yolanda Mitts**, **Jessica Reiser**, and **Eileen Schoenfeld**. One of our responsibilities is to review requests for funding and make sure they comply with IRS rules.

Additionally, **Julia Costello** was a long-time active member. She provided the impetus for the creation of an endowment fund which is part of our education fund. The purpose of this fund is to provide for the financial stability of our local league. To honor Julia's memory and support, we have established the *Julia Costello Legacy Circle* to recognize visionary members and friends who have made lasting gifts to the LWVKAED. Please help secure our future and consider making a donation. It is through this side of the League that voter information and citizen education activities are funded.⁹⁹
