## President's Column

### LWVUS Convention Highlights

The League of Women Voters National Convention was held in Chicago from June 28 to July 1 near the Congress Plaza Hotel where the LWV was founded in 1920.

There were more than 1000 delegates in attendance, 52 from Michigan, and half were first timers. We participated in the adoption of program for the next two years. Delegates strongly supported continuing to focus on The Campaign for Making Democracy Work®. It includes ensuring a free, fair and accessible electoral system for all eligible voters by focusing on:

- Voting Rights
- Improving Elections
- Campaign Finance/Money in Politics
- Redistricting.

Advocacy for the National Popular Vote (NPV) bill was also supported. In states where the bill has been passed it directs their electors to vote for the presidential candidate who wins the national popular vote. Currently 172 of the 270 electoral votes needed to win have been secured. Legislation for the NPV bill has been introduced in Michigan but it has not passed here.

There were many outstanding speakers who gave us insights into timely topics such as the Supreme Court decisions on redistricting in Wisconsin and Maryland, and what's happening with elections across the country and what is needed to improve them. We heard about various Leagues' measures to enhance their own diversity, equity and inclusion, and about efforts to increase the recognition of historical women commemorated on currency and in public monuments. The incoming LWVUS CEO, **Virginia Kase**, was introduced to the delegates and from her remarks, we can be assured that she will embrace the mission of the League and its emphasis on Diversity, Equity and Inclusion. We were encouraged to recruit members who reflect the communities in which we live.

Prior to the general meeting sessions each morning and each evening, caucuses, workshops and information exchanges gave us opportunities to hear from League members who are advocating for policies such as universal, quality,

affordable health care, the final steps to ratification of the Equal Rights Amendment, and carbon pricing to address the accelerating impact of climate change. Other sessions provided information on such topics as cutting-edge Get Out the Vote efforts and types of IRS non-profit status.

The Saturday night banquet featured awards for outstanding projects and accomplishments by local Leagues around the county. The keynote speaker

was Elaine Weiss, author of *The Women's Hour: The Great Fight to Win the Vote, a captivating history of the suffrage movement.*

If you have an opportunity to attend a National League of Women Voters convention, you will find it inspiring and well worth your time!

## 98th Women's Equality Day Celebration

More than 200 community people attended the 98th Women's Equality Day Celebration, co-sponsored by the YWCA and LWVKA, at the WMU Fetzer Center on Friday, August 24th. Women's Equality Day celebrates the passage of the 19th Amendment of the U. S. Constitution which gives citizens the right to vote, regardless of gender.

**Khalilah Spencer**, Voter Rights Advocate and Representative of the Detroit Branch of the NAACP, was this year's keynote speaker. Her theme was "Now the Pink Wave is Here". Ms. Spencer spoke about the disparity between the number of women in our population and number of women who serve in government seats locally, statewide and nationally. A positive sign is that women running for office is on the increase, especially for this year's mid-term elections. Ms. Spencer also talked about the importance of the **Promote The Vote** ballot initiative and how it will help reduce barriers for voters. She said it is up to each of us to ensure that women and all minorities have full access to the political process.

Thank you to all of the LWVKA members who helped to make this event successful. Denise Hartsough, and Paula Manley spent part of the year meeting with YWCA staff to plan the celebration. Paula Aldridge, Barbara Dircks, Denise Hartsough and Kay Perry assisted with a mass mailing. Martha Cohen hosted a voter registration table at the event. Paula Aldridge took care of the LWVKA display table. Denise Hartsough, Chris Kuthe, Paula Manley and KC Miller assisted with greeting and seating attendees. Our President MerriKay Oleen-Burkey welcomed guests on the behalf of the LWVKA, emphasizing the importance of the 19th Amendment and the work yet to be done to ensure all voters have equal access.

### LWVMI Redistricting Court Case

The League of Women Voters of Michigan is lead plaintiff in a landmark partisan gerrymandering case, *LWVMI v. Johnson*. The trial is set to begin February 5, 2019.

### Promote the Vote Ballot Proposal

The Michigan ACLU, NAACP and LWV turned in over 430,000 signatures to put a voting rights amendment on the November 6 ballot. The Secretary of State's office did not automatically certify the proposal after review of a first sample of signatures, but will review a second sample by August 28.

The Detroit Regional Chamber of Commerce endorsed the measure in July. "The health of our democracy requires active participation from voters," said **Sandy Baruah**, president and CEO of the Detroit Regional Chamber. "The voting rights ballot initiative will make it easier for voters to speak and bring Michigan more in line with voting practices of other states across the country."

### Proposal 2 – Redistricting

On July 31, 2018, the Michigan Supreme Court ruled that the Voters Not Politicians redistricting proposal is not an impermissible redrafting of the Constitution and so may appear on the November 6 ballot.
