Difficult Times — New Opportunities

We all know that League work does not stop in spite of concerns created by COVID-19...

- This is a critical time in a busy election year
- Work has begun to support the Census.
- The Kalamazoo League is working on an aggressive new 3-year program.
- Our partnership with a new Kalamazoo Public School Voter Turnout Initiative may become a primary 2020 goal.
- The Kalamazoo Area League welcomes mentorship of Calhoun County as a new Geographic Unit as the Grand Rapids Geographic Unit moves to the next level of independence.

In order to meet our routine challenges and those that have come to us unexpectedly, we are preparing ourselves. To reach voters, we are considering creative alternatives that align with principles of social distancing. LWVKA is implementing online meeting options to keep our work moving forward. In an unprecedented move, the state decided that all Michigan voters who will vote in the May 5th election will receive absentee ballot applications. The May election includes only ballot proposals. If there are no ballot proposals in your city, village or township, you will not receive a ballot application.

- VOTE411 is more relevant than ever
- VOTE411.org will remain an up-to-date source for any election changes related to the virus that may impact election administration.
- Voters who want to limit their exposure to crowds should request an absentee ballot. Visit VOTE411.org and click on Michigan to find the rules for our state.
- Encourage voters to make an election day plan by confirming their polling place and hours. VOTE411.org will be kept up to date with any last-minute changes that may impact election administration
- Shorten time at the polls by doing research in advance. Check out candidates and learn about ballot measures at VOTE411.org.
- LWVUS is providing resources

LWVUS has provided resources for Leagues on the League Management Site. Please see the LWVUS update provided by Paula Manley in this issue of *The Voter.* All states are called on to expand no-excuse absentee voting and mail-in ballots, as well as in-person early voting opportunities for the duration of the 2020 election cycle. It is imperative to limit the need to cast in-person ballots and reduce lines at polling places. We can be proud of our recent work in Michigan that expanded voter access and we must encourage voters to take advantage of absentee voting options. We have new motivation to further modernize voting practices.

Lets remain focused in this time of crisis as we work to keep ourselves, our families, and our community healthy.

Your State League stays committed and carries on during the pandemic:

- LWVMI will gather information from candidates for State office for the LWVMI printed Voter Guide and online VOTE411.
- LWVMI formally supports 3 statewide ballot proposals: Fair Tax MI (graduated income tax), Coalition to Close Lobbying Loopholes, and Fair and Equal Michigan (LGBTQ and religious rights). League members may help collect petition signatures and publicly support these ballot proposals.
- A committee is gathering materials for the statewide study of the State legislature's lame duck period.
- LWVMI has applied a "DEI lens" to its print and online materials, and will revise them according to the reviewers' assessment.
- The LWVMI office is now staffed by Lynda Harwood, Administrative Professional.

Welcome Calhoun County Geographical Unit!

e welcome a new Geographical Unit in Calhoun County as part of the LWVKA! On March 23rd LWVKA co-presidents MerriKay Oleen- Burkey and Fran Eckenrode, Paula Manley, LWVMI VP Membership, Christina Schlitt, LWVMI President, and seven Calhoun County residents met via Zoom to discuss formalizing the Calhoun County Georgraphical Unit as part of the LWVKA.

We already have thirteen LWVKA members who live in Calhoun County — some have been members for several years and others have joined recently. Calhoun County members will be able to work on various LWVKA activities in their county with the guidance of LWVKA Board members.

This came about when Sue Rosko, a LWVKA member from Marshall, talked to friends about the work the League does. She asked about next steps in forming a League group in Calhoun County. Paula Manley, LWMI VP Membership, met with the interested group in January to talk about the League and what becoming a Geographical Unit entailed. They decided they wished to form a Calhoun County Geographical Unit which is the first step in becoming an independent League. Part of this process requires a Local League mentor. At the February Board meeting the LWVKA Board agreed to be the mentor League. LWVKA has experience being a mentor as they have been mentoring the Grand Rapids Area Unit for several years. In the future you will be seeing information about LWVKA Calhoun County Unit. 🕑

Yolanda Mitts — A Tribute

1946-2020

Yolanda Mitts, a long time active member of the League of Women Voters of the Kalamazoo Area, died on February 16, 2020. We will miss her many contributions to our League activities.

In spring of 2019, Yolanda volunteered to be a delegate to the state League convention. She was immediately drawn to the suffragist exhibit commemorating the 100th Anniversary of LWV of Michigan. Yolanda had already been thinking about the 100th Anniversary of the LWVUS and the Kalamazoo League in 2020. She had joined the Centennial Committee and was instrumental in helping to plan the Kalamazoo Valley Museum exhibit, *'The League of Women Voters First 100 Years*' on display through the summer 2020.

Yolanda's involvement in the League's Diversity, Equity and Inclusion Committee was immediate when the initiative was announced at League Founders Day 2019. At the first meeting she brought articles that told the story of the League's history with diversity and the need for our celebration of the first 100 years to be an honest one. Yolanda not only served as the historian for the League but was also committed to helping us expand the diversity of our organization.

Among her many other contributions to our League, Yolanda volunteered to do voter registration at WMU's Bronco Bash, to distribute Voter Guides around the city and county and for many years served on the League of Women Voters of the Kalamazoo Area Education Fund Board of Directors. In that capacity Yolanda was our conscience. For example while serving on the Education Fund Board she brought to our attention that some of our endowment money invested with Vanguard was in funds that included gun stocks. Yolanda persisted and we contacted Vanguard for recommendations for socially responsible funds with no gun stock investment. We switched the funds and made a recommendation to LWVMI to do likewise. Yolanda helped to make our League better in numerous ways.

Yolanda's husband, Gary, is planning a memorial at the Glen Vista Gallery in the Visitor Center at the Kalamazoo Nature Center (KNC), 7000 Westnedge Ave., Kalamazoo, on Saturday, May 16, 2020 at 2pm. If you will be attending the memorial you are welcome to explore the Nature Center that day. Should the date for the memorial need to be changed, a notice will be sent to the League membership. Ø
