## Annual Meeting Business by Email & Ground Mail

OVID-19 has disrupted our lives but it will not stop our League from conducting business. At the April meeting the Board voted to suspend rules of order for the 2020 Annual Meeting and handle the annual business via email & regular mail instead of face-to-face. Local Leagues around the state are making similar arrangements to conduct annual meeting requirements of voting for candidates, and approving the budget and program.

Business will be conducted by two emails to membership. Those members without email will be addressed via regular mail.

The first email/mailing will seek input from members and will include the following:

- Minutes of the 2019 Annual Meeting
- Treasurer's Report
- Proposed Budget for 2020-2021
- Slate of Candidates
- List of Continuing Board Members, Budget Committee Members, and Nominating Committee Members

The proposed budget and slate of officers were published in the March and April issues of The Voter to allow member input. Members will have the additional opportunity to provide input before the second email/mailing is sent.

The second email/mailing will ask for everyone to vote to accept the minutes. the proposed budget, the slate of candidates, and to adopt the local program without changes. It will also include the following:

- Minutes of the 2019 Annual Meeting (with corrections, if any) Vote
- Proposed Budget for 2020-2021 (with changes/clarifications if any) Vote
- Final Slate of Officers (including additional nominations if any) Vote
- Adoption of Local Program Without Changes Vote
- Education Fund Budget Report (Ed Fund Board approves this budget)

Please look for the first email/mailing in early May and respond promptly with input you may have by the included date requested in each email/mailing. The second email/mailing will be sent later in May and ask everyone to respond with their vote. Voting instructions will be provided.

WVUS has announced that the National Convention scheduled for June 25-27 in Washington, DC will be a virtual event. Delegates will be receiving information regarding registration in early May.

Advocacy Guidance for Virtual Transparency of Government Bodies may be found at Iwv.org/league-manage ment. This guidance will help Leagues advocate for open, transparent and accessible processes when working with government bodies during the COVID-19 and any future emergency situations requiring limited in-person contact.

LWVUS has joined with the National Council of Asian Pacific Americans, Democracy Initiative and more that 150 other organizations to support H. Res 908 and denouncing increased racist attacks and discrimination against the Asian American community.

## **Court Victory!**

A federal appeals court upheld denial of an injunction to halt the work of our state's new Citizens Redistricting Commission (CRC). Fifteen individuals challenged the constitutionality of the CRC's eligibility requirements for Commission members. A US District Court denied the request for an injunction in November 2019. On April 15th the Sixth Circuit Court of Appeals upheld the denial, so the CRC moves ahead. Your State League filed an amicus brief in support of the CRC.

# **GR Unit Updates**

ow do you adapt the work of LWV and events that you have planned to this time of social distancing? This is been the question on everyone's mind as of late. There is so much important work to do this year with important elections, the Census, and so much more, and we can't afford to distance ourselves from this critical work while we remain physically distanced from other people.

Springtime is typically the time we visit area high schools to register students to vote and speak with them about the voting process. We have come up with a way to register voters in high schools while buildings are closed and students are doing distance learning. The Grand Rapids Unit members have been working with principals and teachers on this project. The goal is to encourage students to register to vote online as part of their distance learning curriculum. When the student finishes registering to vote online, they then send a screen shot to the GR Unit to prove success. All successfully registered students will receive a personalized certificate emailed from our unit, and an entry in the drawing for a Bigby gift card. For students who attempt to register but are too young to register at this time (they need to be 17.5 yrs. or older), and they send a screen shot of the message indicating that they are too young to register, they will also be entered in the drawing and be added to an e-mail list reminding them to register when old enough. 🟈







## Kalamazoo County Climate Collaborative Meeting Quarterly

Kalamazoo County and several cities and townships within the county have adopted climate emergency resolutions that include calls for local responses. They have begun meeting quarterly under the umbrella of MSU Extension to learn what is happening elsewhere and to begin to develop local plans. Their second meeting, held online on April 21, featured a presentation from the Marquette Area.

**Emily Leach** is Chair of the Marquette Area's Climate Adaptation Task Force (CATF), which was established in 2013 "to help local leaders and the general public think proactively about the effects of climate change and to develop strategies that will make the Upper Peninsula more resilient and effective when dealing with the consequences of extreme weather events." She explained that CATF includes elected officials. local government staff, and representatives from non-profits, the community foundation, and higher education. MSU Extension has played a key role throughout. The full group meets quarterly, with various workgroups meeting throughout the year. Their workplan includes community resilience planning and implementation, seeking external funding, and providing education and outreach on climate resiliency.

**Brad Neumann**, Senior MSU Extension Educator, described the Marquette Area Climate and Health Adaptation Project, part of a nationwide effort. They are working to connect planning with public health in order to reduce the negative public health effects of climate change. Their Marquette Area Climate and Health Adaptation Guidebook documents community visions and concerns, recommends policies for adapting the built environment, and provides guidance for implementation. Areas of concern include disease-carrying vectors (ticks), air quality, emergency response capability, and extremes in drought and precipitation.
