LWVUS Update

VOTE411.org received the 24th Annual People's Voice Webby Award for the Best Government and Civil Innovation Website on May 19th. The International Academy of Digital Arts and Sciences which gives these awards is the leading international award organization honoring excellence on the Internet.

LWVUS has endorsed a new project — RepresentUs — which creates a space for nonpartisan organizations and a cross section of election officials to promote reforms in states to make voting safe. They have created the website: votesafe.us — a bipartisan platform giving a state by state breakdown of what states need to do, allowing the public to see where and what is being done, and providing resources and advocacy.



Recently LWVUS joined other organizations in a letter to Congress requesting \$40,000,000 for one-time competitive grants to nonpartisan, non-profit civic education programs that have a record of successfully providing effective civic education programs. The goal is to meet the remote teaching needs of K-12 schools and teachers, the home-schooling needs of parents and students and for meaningful student-centered civic learning.

LWVMI Makes Democracy Work!



Leagues around the state reached people 17,447 times in 2019-20 with important information about the 2020 Census, Michigan's new Independent Citizens Redistricting Commission, and our state's enhanced voting rights, including no-excuse absentee voting.

Online retrieval of information nearly matched attendance at in-person events, with nearly 9000 of each. Note that the pandemic forced cancellation of some events in 2020.

A pass-through grant from the LWVUS Education Fund supported this outreach.

Lame Duck Sessions

Local Leagues will help create a State League position on lame duck sessions in the Michigan legislature. Lame duck is the period between the November election and the end of legislators' terms on December 31st.

During lame duck the outgoing legislature can enact bills speedily without having to answer to voters. Lame duck bills in 2018 included efforts to undermine all the newly passed ballot proposals, and creation of a "straits corridor authority" to oversee Endbridge's proposed tunnel under the Straits of Mackinac for Line 5.

LWVKA members will discuss the LWVMI lame duck study consensus questions early in 2021. 🧭

Environment Beat

WVUS takes the position that "as citizens of the world we must protect our planet from the physical, economic and public health effects of climate change while also providing pathways to economic prosperity." LWVKA has taken that national position seriously through the work of its Natural Resource Committee and as an affiliate member of the Kalamazoo Climate Crisis Coalition (KCCC). The KCCC unites organizations and individuals to promote awareness and engagement to achieve immediate and drastic reductions in greenhouse gas emissions and a rapid and just transition to 100% renewable energy in the greater Kalamazoo area.

The KCCC, in partnership with the Kalamazoo Earth Day Festival Committee, Kalamazoo Nature Center, Hope for Creation and several other local organizations and individuals hosted over thirty digital events as part of Virtual Kalamazoo Earth Week 2020 (April 18-25).

The digital pivot was remarkably successful, drawing thousands of visitors to the websites and social media platforms of the major partner organizations. Virtual events provided educational opportunities, art and photography exhibits, messages on how to get engaged in effective collective action, connected people to nature through sharing signs of spring, and highlighted the impact of individual choices in diet, native plantings and transitioning a home to net-zero.

Elected officials participated and supported events in a variety of ways. Kalamazoo Township, City and County all passed proclamations expressing support for honoring Earth Week 2020; encouraging all citizens to participate and recognizing the interconnectedness of all living things on which we depend for our survival. Kalamazoo area officials participated in a climate crisis town hall and discussed climate emergency declarations, climate change impacts and responses. Michigan state and federal officials, including Senators Stabenow and Peters, State Senator McCann and State Representative Hoadley, sent personalized video reflections on Earth Day and the Climate Crisis.

Most events were recorded and remain available for all to discover and enjoy at Kalamazoo Earth Day Virtual Events.

A key take away message from Earth Week was recognition of the robust community of highly committed activists in the Kalamazoo area and that "we are all in this together." The KCCC is thankful for the opportunity to collaborate with affiliates like LWVKA and look forward to continuing to work together to address our ecological and climate crises.





Remembering Carol Urban

Getting up to mischief with Carol was interesting — sometimes funny, sometimes physically challenging, and always an adventure.

I met Carol through the Community Access Center (now Public Media Network) when I took classes in video production in the 1990s. From Carol I learned a lot about how to frame a story, communicate clearly, and engage the audience.

Carol had a wide range of interests; the arts — she served on the Board of Wellspring, the environment (especially the lakeshore), public affairs, and many others. This led to many experiences for me. We video tapped *Bach Around the Block* and developed a series on *Ethics in Public Life*, and began taping (not digital in those days) of the *LWVKA Candidate Forums*. Carol served on the League of Women Voters Board and produced a video to celebrate the LWVKA's 90th anniversary.

Carol and I have sons the same age who became friends in high school. That of course led to other exploits related to education and the challenges of rearing teenagers.

Some of my fondest memories were hearing about all her travels. She read extensively before traveling and her curiosity led to great stories and unusual souvenirs from far-flung places all over the U.S. and the world.

Carol's generosity ranged from the particular to community-wide. Many organizations and individuals benefited from her fund-raising.

Like all friends everywhere, I wish we could have had more time together and will miss her very much. 🏈


