President's Column

2019-2020 Annual Report

The Centennial Year for the League of Women Voters of the Kalamazoo Area has been a memorable one. Despite a three-month shutdown, we have been able to carry out our mission of 'Empowering Voters and Defending Democracy' with the help of many LWVKA volunteers and we accomplished a great deal this year. Highlights from the year are described below:

Administration & Governance

Centennial Activities:

- Centennial Celebration Activities were highly visible as the League partnered with area libraries and the Kalamazoo Valley Museum to showcase the 100th anniversary of voting rights for women as well as the 100th anniversary of the League of Women Voters. In November and December of 2019 the Parchment Library hosted the first display, arranged by **Barb Dircks**. A display created by **Linda Timm** and **Madeleine Socha** was shown at the Portage District Library from late December, 2019, through February, 2020. The display included a continuous PowerPoint video featuring the struggle for women's suffrage and the history of the League of Women Voters. This display was moved to the Schoolcraft Library just prior to the Covid-19 shutdown.
- A League-sponsored exhibit "League of Women Voters—The First 100 Years" opened at the Kalamazoo Valley Museum in mid-December and remains on display through the end of 2020. A public reception was held at the Museum in January to mark the opening. A traveling version of the display will be featured at the Kalamazoo Public Library and KVCC later in 2020. The Museum's online magazine MuseON included an article in the winter edition: League of Women Voters: First 100 Years "Empowering Voters. Defending Democracy". The display and article were created by Leaguers Chris Kuthe, Barb Dircks, Yolanda Mitts, Cheri Bell, and Fran Eckenrode in collaboration with Museum staff Alecia Cross and Tamara Barnes.
- LWVKA's Founders Day celebration at the Fetzer Center was its Day of Action highlighting our 100th Anniversary
- Among several events celebrating the LWV centennial, the Grand Rapids Unit partnered with the Women's History Council at the Grand Rapids Art Museum to provide information on the history of women's suffrage.

2020-2023 Strategic Plan: On October 6th, the LWVKA board held a retreat to initiate a three-year strategic plan. **Terry Hluchyj** opened the process and the result was the following five areas chosen for emphasis and goal-setting:

- 1. Redistricting and the Census—Support full representation of Kalamazoo County residents in order to ensure fair distribution of public resources and legislative influence.
- 2. Climate Change Contribute to local efforts that align with global climate strategies and goals.
- 3. Diversity, Equity and Inclusion—Engage in purposeful action to advance di-Continued on page 3

LWVUS sent comment to the U.S. House Judiciary Committee ahead of the Oversight Hearing on Policing Practices and Law Enforcement Accountability on June 10. The committee is considering legislation such as the Justice on Policing Act of 2020 and other legislation addressing justice reform in America.

LWVUS recently:

- Joined 200 organizations led by the Leadership Conference in sending letters to the Department of Justice calling on investigations into the circumstances surrounding the killing of Breonna Taylor and George Floyd.
- Joined over 400 civil rights organizations in a letter calling on Congress to implement needed policing reforms.
- Joined public health organizations in expressing concern over the U.S. government's decision to terminate the relationship with the World Health Organization. It also calls for the support for the recently proposed WHO resolution WHA 73.1 calling for governments around the world to impartially and equally address the COVID 19 pandemic.

LWVMI Updates

Your State League in Action!

WV of Michigan has endorsed the VoteSafe MI Coalition, a cross-partisan campaign to ensure that voters can vote safely during the pandemic through expanded access to absentee ballots and safe, sanitary and accessible in-person voting locations. The campaign is led in Michigan by Secretary of State **Jocelyn Benson** and former Congressman **Joe Schwarz**, and nationally by former Republican Governor **Tom Ridge** and former Democratic Governor **Jennifer Granholm**.

LWVMI protects voters in the courts, as well. The State League is the lead plaintiff in:

- the "Postmark" lawsuit, which challenges the constitutionality of the law requiring that absentee ballots be received no later than 8pm on Election Day. LWVMI asks that ballots be counted if postmarked on Election Day.
- a lawsuit challenging PA 608, passed in the 2018 Lame Duck Session, which makes signature collection for ballot proposals more difficult. LWVMI awaits a decision by the Michigan Supreme Court.
- filed an Amicus Brief in support of Secretary of State Benson and Count MI Vote in the lawsuit by the Michigan Republican Party against the Citizens Redistricting Commission. The 6th Circuit Federal Court denied the Party's claim. The Party appealed to the full Circuit Court of 16 judges, the majority of whom declined to hear the case. The Party may appeal to the US Supreme Court. I

- 5. Housing—Contribute to local efforts designed to increase affordable housing and eliminate homelessness

Grand Rapids Geographical Unit: Work-

ing with the Grand Rapids Public Library, the Grand Rapids Unit compiled the history of the women's suffrage movement in their area that will fulfill a requirement to becoming a MAL (Member-at-Large) Unit. This is the next step for them to grow into a local League.

New Calhoun County Geographical Unit:

On March 23, 2020, a Calhoun County Geographical Unit was formed as part of LWVKA. **Paula Manley**, LWVKA member and LWVMI Membership VP, is serving as their mentor and **Sue Rosko** is the GU leader and board representative.

Promotion Committee:

Debbie Phillips assembled tabling kits for promotion tables at community events such as Global Climate Strike and Martin Luther King, Jr. Day and organized a *zazzle*. *com* store with sales of imprinted products benefiting our league. A banner with the new Vote411 logo was prominently displayed on the Westnedge walkover prior to the November election.

Book Discussion Group: Organized by **Aedin Clements**, the group continued to meet bimonthly to discuss books dealing with topics such as Climate Justice, Racism and more.

Leadership: Members of LWVKA continue to serve on the LWVMI board. They along with three other members represented us at the virtual LWVUS Convention in June.

Issue Study & Advocacy

Diversity Equity and Inclusion Committee, chaired by **Millie Lambert**, recommended the board adopt the LWVUS Diversity, Equity and Inclusion Policy, and it replaces the existing LWVKA Diversity policy (page 5 of the LWVKA Handbook). At its monthly meetings, the committee members are engaging in discussions about DEI topics using *Ted Talks* and webinars to increase their awareness. Early in the year they initiated the "*DEI Events to Consider*" column in The Voter to bring them to the attention of the membership. The DEI Committee has adopted a 2020-2021 Action Plan that will be discussed by the board in July.

Women's Equality Day: The 99th Women's Equality Day commemorating the passage of the 19th Amendment was cohosted by the YWCA and LWVKA on August 23, 2019, at the Fetzer Center. The keynote speaker was Fadwa Hammond, Michigan's Solicitor General and the first Arab American Muslim Solicitor General in the United States. She has also been a member of the LWV of Dearborn/Dearborn Heights.

LWV Lake Michigan Region: LWVKA member Ruth Caputo was co-chair of the LWV Lake Michigan Region Annual Meeting covering Michigan, Illinois, Indiana and Wisconsin. It was held in Lakeside, Michigan in October. The theme was "The Great Lakes and Groundwater." The keynote speaker Liz Kirkwood representing For Love of Water, spoke on "Groundwater: The Sixth Great Lake." Speakers and environmental field trips in the area continued the theme.

Voter Outreach & Education

Three issues were the focus of LWVKA and the Grand Rapids Unit voter education this year: Voting Rights, Citizens Redistricting Commission and the 2020 Census. Organized by **Denise Hartsough**, VP of Program, a Town Hall, *"Know Your Voting Rights"* was held in conjunction with the Secretary of State's Office on November 14 at El Concilio in Kalamazoo. The Town Hall leaders also explained the importance and the logistics of the Citizens Independent Redistricting Commission; 15 audience members completed applications to serve.

In March, **Denise Hartsough** enlisted the help of LWVKA volunteers to assist with the Census at Ministry with Community in Kalamazoo. Unfortunately, the project could not be initiated due to the pandemic.

The Grand Rapids Unit collaborated with the United Way, the Census Hub for Kent County, to encourage participation in the census.

Voter registration / education events included WMU Bronco Bash, National Voter Registration Day at Ministry with Community, KVCC Cougar Kick-off (fall and winter semesters), Stand Down 2019 in Kalamazoo. Martin Luther King Jr. Celebration at WMU, Global Climate Strike, and the Women's March in Kalamazoo. The Grand Rapids Unit hosted events at the Women's History Council; Cherry Health Westside; East Kentwood Homecoming Game & Community Festival; First Friday at Linc Up; the Kent District Libraries; the Grand **Rapids Housing Commission communities** of Creston Plaza, and Campau Commons; and Grand Rapids high schools. Linda **Pell** a LWVKA member in Battle Creek. conducted voter registration events at high schools in Marshall and Battle Creek prior to the Presidential Primary in March. Many LWVKA volunteers made these voter registration events possible.

Candidate Forum: Approximately 150 people attended the Candidate Forum organized by member, **KC Miller**, for eight Kalamazoo City Commission Candidates and four Mayoral Candidates on October 2.

Vote411/Voter Guides: Jules Isenberg-Wedel reported that 14,950 paper voter guides were created and distributed throughout the county by LWVKA volunteers for the local elections in November 2019. Additionally, Vote411 served as the electronic voter guide for these local elections as well as for the March Presidential Primary and the May ballot initiative election.

Panel on Women Office Holders:

Courtney Winell from the Grand Rapids Unit was invited to facilitate a panel discussion of four current and past women public office holders in the Grand Rapids area for the Women in Successful Enterprises (WISE) group at their event, *"Women in Office Mean Business,"* August 21, 2019. The mayor of Grand Rapids was one of the panelists.

Election Administration

The LWVKA Donor Appreciation Event organized by the LWVKA Development Committee was held on September 12, 2019, and featured County Clerk **Tim Snow**, who provided an update on Michigan enhanced voting rights passed by the voters in 2018; he explained how these changes impact the work of his staff. **③**

LWVKA Celebrates 100 Years

One hundred years ago on July 20, 1920 local women who had been involved in the Suffrage Movement organized the Kalamazoo League of Women Voters. This was five months after the League of Women Voters of the United States was formed in Chicago on February 14, 1920. Dr. Caroline Bartlett Crane, Mrs. Caroline Hubbard Kleinstuck and Mrs. Leah (or Lydia) Shakespeare were among the Kalamazoo founders. The stated purpose of the group was to further the political education of the newly enfranchised women. In the fall of 1920, the first non-partisan rally for candidates was held with 2,000 people in attendance. It was called *"an innovation in political gatherings"* and considered a great success.

In 1925 the Michigan League of Women Voters held its annual convention in Kalamazoo and **Mrs. Carrie Chapman Catt**, Honorary President of the National League, attended. The Kalamazoo League was active through the 1920s and 1930s. Somewhere in the late 1930s it appears some of the prominent members died and there is no mention in the Kalamazoo Gazette of the League for a period of years.

In 1951 a group of women organized a Provisional League with **Caroline Ham** leading work on the *"Know Your Town"* study. The LWV of Kalamazoo was once again active in the community. In 1963 a League study found a shortage of housing for minority group members. The League supported an open housing ordinance and building code enforcement in the city which was approved. In 1973 LWVKA was an amicus curiae in a successful suit supporting Kalamazoo Public School desegregation. League President **Mary Brown** delivered the brief to Washington and testified before Congress.

In 2004 the League expanded its service area to include the entire county and became the League of Women Voters Kalamazoo Area. Throughout the years LWVKA has encouraged informed and active participation of community members in government and influenced public policy through education and advocacy.

The League began as an organization of mostly white middle class women, and welcomed its first male member in 1974. We are joining the LWVMI and LWVUS in focusing on diversity, equity, and inclusion as we look forward to the next 100 years of *"Empowering Voters. Defending Democracy"*.


